## "....deja vu all over again"

All of us served one tour in VN, most a second and some a third. Even some of us returned to the same unit, but how many of us returned to the same place, same unit and same job assignment? Well, we have at least one in our corral of Outlaws, MSG (Ret) Raymond E. Hall. You may remember him as first our Ops Sgt, and then, shortly after our arrival in VN, as our First Shirt for the remainder of his tour.

A little background on Ray's career. Enlisted in 1946, basic training then stationed in Japan with the 8th Army Occupational forces. The next fifteen plus years a variety of AG assignments followed in CONUS and Korea. Late in his career 1964 time frame. Ray was sent to Ft. Rucker for a crash two month aircraft maintenance course followed by assignment to the 11th Air assault Division (Test) at Ft. Benning, GA. Evidently not satisfied with his aircraft maintenance experience (why did they send an AG guy to Rucker aircraft maintenance course anyway?) Ray attended an in house 11th AAD Flt Ops Training Course for 3 months then, a short stint with HQ 11th AAD. Well within 3-4 Years before eligible for retirement he was "volunteered" for the 62nd Avn Co (Later Co A, 502d Avn Bn), a unit organized from 11th AAD assets slated for deployment to VN in Sep 64, and assigned as the Ops Sgt. The rest is history as they say, well almost. Shortly after arrival in VN, as senior SFC in the company, he was bucked up to the 1SGT position. Through some quirk of luck an E8 promotion soon followed with Ray filling the 1SGT position until DEROS in sep 65. As might be expected, return to CONUS found him assigned to a WOC Co at Ft. Rucker. In Aug 66, guess what? Now, just with over a year before eligible for retirement, ORDERS FOR VN! Most would have fought the system, but our dedicated 1SGT saluted the flag pole and was on his way by Sep66. Landing at Tonsonhut, Gateway to the exotic Orient, he soon found out he was to be assigned to the 114th Avn Co as 1SGT. "Hey wait a minute", someone must have said, this guy has been here before why not send him back to his old unit the Outlaws (about now the 175th AHC)? As you might expect, that is exactly what happened with Ray Back at his same old desk, same old unit and same old place Vinh Long, as Yogi Berra once said, "...deja vu all over again".

Ray's story doesn't end here. On his return in Sep 67 to CONUS from the second VN go around, he found himself assigned to an ordinance company at Ft. Hood, TX (Hmmm???????). He retired from the US Army in Oct 67. Ray

didn't go fishing following his retirement: first employed as a foreman at cannery company for a short period he applied and was selected for a position with the Missouri Department of Labor. He continued a career in that department until his real retirement in Mar 91. Ray settled down in Bridgeton, MO after his retirement from the USA and continues to live in the same house. Ray and his wife, Shirley, whose teaching career covered some twenty years, recently celebrated their 50th wedding anniversary. They have four children and nine grand children. The airlines are benefitting from the Hall's travels in the US and abroad. A short postscript to this story. For months the search for Ray wandered down many avenues only to reach dead ends. Finally, we resorted to using some horsepower and with the kind auspices of a retired three star we found him! We are looking forward to seeing Ray and Shirley in Branson, MO September 15-18 for R2Kk.

It's a long way from gun ships to the pulpit. Vinh Long in 1964 and 1965 seems like a lifetime ago. In a sense, it was. After two more tours in RVN, and an assignment in Alaska, I found myself standing in civies with a HS GED in one hand and a medical retirement in the other. The job market was tight and I couldn't find a gun ship CE position anywhere.

In 1971, I entered Austin Peay State University and received my degree in 1974. After working in hospitals as Director of Environmental Services a few years, I got back to church and the Lord. In 1978, I

answered God's call to ministry. I enrolled in the Master of Divinity program at Southeastern Baptist Theological Seminary at Wake Forest, NC. Following graduation, I pastored churches in North Carolina, spent a few years as a vocational Evangelist, and finally returned to the pastorate until 1997 when I retired and moved to Florida.
