Wow! What a great VLOA Roundup Joe and Erline Clelan planned, coordinated, and conducted. Roundup attendees arrived on Thursday afternoon, checked-in to the Sheraton Harrisburg/Hershey hotel, and were promptly greeted by our Roundup Greeters dispensing goodie bags and selling 50-50 tickets for cash prizes to be drawn for at our farewell dinner on Sunday night. After a bunch of socializing and cocktails, attendees moved to the hotel's outdoor dining room for a Welcome-Back Buffet with all the food you could eat. This was followed by a lot more meeting and greeting in the hospitality room, including opening the Silent Auction room for bidders.

Friday was a very busy day, beginning with a wonderful and substantial buffet breakfast. Afterwards, we boarded the busses for a quick ride to Gettysburg for the Battle Theatre Show about the Battle of Gettysburg. Then, we moved downstairs to the General Pickett's All-You-Can-Eat Buffet Restaurant, where we gorged ourselves. From this venue, we again boarded the busses for an actual riding tour of the Gettysburg Battlefield, with each bus using a battlefield guide to explain the significance of the various areas we were driving through. This kind of tour really shed more light on our understanding of the Battle of Gettysburg.

the Steering Committee hiring a reunion planning organization for future Roundups, (6) posting pages on our website to deal with issues related to copyrighting our logos and changes to our constitution, and (7)evaluating the possibility of permitting sons and daughters of VLOA members to become members of the organization. Then, back on the busses for the trip to the American Music Theatre, where a great musical caste entertained us with a presentation of the British Invasion Show, with songs from many of the British singers and other well known artists. 

Chester Voisin "All Tuckered Out"



Director's Award Winners

Those of you who attended the R2K+8 Roundup know who won this award, so bear with me as this article will inform the rest of our Outlaw herd on who won the award and why.

Each biennial Outlaw Roundup recognizes an individual whose substantial contributions to the success of the VLOA have been above and beyond the call of duty. This award is unmatched by any other Viet Nam veteran's organization, including the Army Aviation Association of America, the Viet Nam Helicopter Crewmembers' Association, The Viet Nam Helicopter Pilots' Association, and all other prestigious veterans' organizations that have evolved since the Viet Nam conflict. The Director's Award is the consummate award that can be given in recognition of service to an organization whose membership includes such stalwart characters as those composing the VLOA.

Our awardee was there even before there was an "Outlaw" name applied to the illustrious organization. That beginning was back there at what was often called the Benning School for Boys. Our awardee was there when the name "Outlaws" was selected by a member of the Mavericks, and was also there at another beginning - - - even before there was a name applied to what we now know as the VLOA.

After the "First Branson," our awardee was instrumental in cobbling together the concept for an Outlaw Roundup with as many of the old Vinh Long group as could be found. That reunion was planned to be the one and only reunion of that tired bunch of old soldiers. But, when the old vets came together at Branson and all the follow-on reunions, our awardee was right in the middle of anything that needed to be done.

At Branson, our awardee was instrumental in setting up the registration, welcoming attendees, scheduling the agenda, preparing the gift bags, and a hundred other necessary actions to "just make it work." It may be coming clear now to the reader that it wasn't just one person doing all these things by himself. It took two people to make these things happen, and one of them was a woman. This year, it became clear that the selection committee would have to consider two people for the prestigious Director's Award.

As the VLOA became organized, structured, and viable, we needed a leader; someone who could guide this fledgling group through its formative years. One of these two people became our first VLOA Director. The other was a wizard with finances, served as the first VLOA Treasurer and was a master with compute agendas, photos, and a myriad of other technical support needs. So, over the next 10 years, these two individuals continued to be in the forefront of planning, creating, recommending, and involvement in every Roundup we have had. They have been a wellspring of great technical advice, always ready, willing, and able to fill any role wherever and whenever needed. Treasurer's Report

"Well, it was quite a reunion. I think I've finally recovered from all the math and exotic calculations involved balancing the books for our Reunion!!!!!!

This year, we are winding up with a good bit less then at the end of R2K+6, when we had approx. \$19K to start 2007 with. This short fall is due to the large amount paid by the general fund in order to keep member cost at a reasonable level. This added up to approx \$12K (for the 2 bus, cancellation refunds and miscellaneous expenses).

Unless there are objections, I plan to deposit approx. 75% of our current funds in an interest bearing CD, as we did after the last reunion.

The \$1,000.00 donation to Fisher House has been subtracted from our check book, but the funds have not yet been sent, as I've run in to a lack of co-operation in identifying the proper party to send the funds to at the national organization. I will keep you posted on progress. I would also like to mention a very generous action on Al Iller's part. Al is one of the \$300.00 winners in the 50/50 drawing. He returned his check to me, with instructions to include the amount as part of the group's donation. It gives me great pride to be part of a group that includes people like Al.

Special thanks also to Bill and Gracie Hensinger for their non-stop efforts during the reunion. Quartermaster sales, under their supervision, brought in \$561.00.

Finally, it would not be a successful and fun reunion without Emmadel and Pat -et al - waving handful of 50/50 tickets at all of us. In addition to the 50/50 dollars brought in as part of the reunion fee, they added another \$580.00 to our coffers."

Preventing the Loss of your Airman Certificate Privileges Angelo Spelios Your friendly FAA inspector (until January 3, 2009)

The Federal Aviation Administration (FAA) issued new regulations regarding the duration of pilot certificates, flight engineer certificates, mechanic certificates, and aircraft dispatcher certificates. FAR 61.19 states that the holder of a paper pilot certificate issued under this part may not exercise the privileges of that paper certificate after March 31, 2010. FAR 63.15 states that the holder of a paper flight engineer certificate may not exercise the privileges of that paper certificate after March 31, 2013. FAR 65.15 states that the holder of a paper mechanic or a paper aircraft dispatcher certificate may not exercise the privilege of that paper certificate after March 31, 2013.

You can replace your airmen paper certificate's with a new plastic credit card size airmen certificate by logging on to <u>http://</u> <u>www.faa.gov</u> and clicking on "Replace a License Certificate" under "Pilots" on the right side of the page. Then click on "Login to" and select "Request an Account" at the bottom of the page that comes up. Follow the instructions to obtain a new plastic certificate. Each certificate will cost \$2.00, which you will pay with a credit card online. You may also, at the same time, if your certificate number is the same as your social security number, request that your social security number be removed as your certificate number.

The International Civil Aviation Organization (ICAO), of which the United States is a member, issued a requirement that as of March 5, 2008, all private, commercial or ATPs, as well as flight engineers, operating internationally as required crewmembers of an airplane or helicopter have an airman certificate with an endorsement of language proficiency. In the case of persons holding a U.S. airman certificate, the language proficiency endorsement will state "English Proficient." U. S. airmen certificate holders have until March 5, 2009, to comply with the ICAO Language Proficiency airman certificate endorsement requirements. After March 5, 2009, U. S. airmen certificate holders may not operate internationally without this endorsement.

If you replace your airmen certificate as described above, the "English Proficient" endorsement will be added to your certificate automatically because the ability to read, speak, write, and understand English is already a U.S. regulatory requirement. The FAA Registry began issuing all new certificates with this endorsement on February 11, 2008.





Include a signed, written request stating your name, date and place of birth, social security number, and/or certificate number, your current address, and the reason you need a replacement. You must include a check or money order for \$2.00 (U.S. funds), made payable to FAA for each certificate you are requesting

Even if you are not currently exercising your airman privileges, you worked very hard to obtain them. Please take a little time to retain those privileges by requesting replacement certificates.

Search for the Rest of Our Gang

During our Business Meeting, we discussed and approved changes to our Constitution and By-Laws that will permit Outlaws, Mavericks, Roadrunners, and 28th Signal members from year-groups subsequent to September 1965 to be VLOA General Members. Current General Members (those in the units from August 1964 through September 1965) will be re-designated as Charter Members.

With these changes, we must begin the process of locating rosters from the various year-groups of the 175th and U.S. aviation units in Iraq, identifying individuals and groups who can assist in locating former members, and corresponding with these former members in an attempt to get them to join the VLOA. As you can well imagine, this will be a long and laborious process, but we must do this now or we will soon reach the point were age and health results in future Roundups where only a few of us are able to attend. We must establish a process now that ensures the Outlaws' legacy continues well into the future.

There are a number of processes we can use in this effort: find a point-of-contact in each year-group and seek their assistance; appoint current VLOA members to assist in the effort; and, use a professional search service to find potential members. Right now, it appears that we will need to use a combination of all these efforts if we expect to make progress prior to our next Roundup. If the Outlaw units following 8/65 turned over at approximately the same rate as our time group did and assuming the unit remained about the same size, we are conservatively talking about looking for 4,000+ from 8/65 through the end of the Viet Nam War.

Additionally, Director-At-Large Dave Logan has agreed to undertake the task of locating the remaining 250 original Outlaws, Mavericks, and Road runners whom we have not been able to locate from our original list of some 500 that fall within the August 1984 – September 1965 time frame.

So, the process has started. Your new officers have accepted this strategic mission so as to arrive at a R2K+10 Roundup with other year-groups represented. We are walking on new ground, and will need all the support we can get in this effort. If you have ideas, don't be bashful about sending them to me at <u>estesf@charter.net</u>. Thanks in advance for anything you can do in this regard.

WHERE DOES THE VLOA TREASURY GET IT'S MONEY?

The primary purpose of our Vinh Long Outlaws Association is to have a reunion every two years for all of us who served together in 1964-65. Our Constitution even states that the first objective of the organization is "to renew and preserve the camaraderie and esprit de corps among members of the VLOA".

Each of our reunions has been WONDERFUL! The camaraderie among the attendees is unbelievable.


Those who have attended will confirm that each reunion has been "first-class". To do this, every reunion coordinator has had to balance the costs of providing all the necessary amenities against the reality of keeping the cost-per-person within feasible limits. This is not easy!


Back in 2000, we did not have a VLOA treasury. Several individuals among the "Charter Members" each contributed money to initialize a small treasury to fund the costs of the Newsletter. The first membership meeting approved an annual "membership fee", however that income barely covered the Newsletter costs. And, annual membership fee income is now decreasing because many members have opted for a Life Membership.

But, reunions cost money! In order to provide money for such items as refreshments, banners, signs, gratuities, recognition and thank-you gifts, etc., the first reunion coordinators resorted to assessing a small fee on top of each attendees costs. Several reunions ago, we began our spirited 50-50 program to provide a better funding source for the treasury. We also initiated our "Silent Auction" program to augment the treasury.

Those two programs, (50-50 and Silent Auction) are the principle means the VLOA has to put significant money into the treasury. Therefore it's obvious that the treasury has been built, and sustained, primarily by those who <u>attend</u> the reunions. And, it should be used to continue to make the reunions as first-class as possible. At this writing, a location for R2K10 has not been selected. However, wherever it is held, prices will be higher two years from now than those in the past. The treasury will be used to underwrite certain amenities for that reunion.

The two revenue program sources cited above brought in far less money at Hershey than in previous years. The primary reason was that there were fewer attendees to bid on auction items or purchase 50-50 tickets. The treasury is still sound but will continue to need the support of those who attend the reunions. Thanks to everyone who supported the 50-50 and Silent Auction at Hershey. The Steering Committee is working on ways to increase both the membership in the VLOA as well as attendance at the next reunion. Stay tuned for further developments.




COPYRIGHTS REVISITED

The lead article (page 1) of the VLOA Newsletter, January - March First Issue 2007 provided background, decision process and final approval by the U.S. Copyright Office for the copyrights to the original artwork of the Outlaws patch, 150th CHFM patch, 28th Sig Det patch and the Maverick and Roadrunner logos. In that article, it was stated that the purpose and intent of the copyright effort was to preserve and protect historically the artwork and designs of the patches and logos as originally created by members assigned and/or attached to the 62nd Aviation Company (later re-designated Company A, 502nd Aviation Battalion), 150th Cargo Helicopter Field Maintenance Detachment and 28th Signal Detachment when first deployed from CONUS to VN in late 1964. These five patches/logos were approved by the U.S. Copyright Office in August 2006 as of September 2005 submission.

Since the approval of the VLOA copyrights, there have been comments and concerns from various sources as to the intent of VLOA's copyright action. As set forth in the above earlier referenced article, and reiterated above, the purpose was to historically preserve and protect the original artwork and designs through the copyright action. And as quoted in that same article, "The wearing, display, reproduction, use, etc. by any former members of the 62nd Aviation Company; Company A, 502nd Aviation Battalion of the 1964-1965 era, the follow-on 175th Assault Helicopter Company and all their attached units/detachments, throughout their service in RVN, of these original designs and derivatives thereof would not be infringed upon nor inhibited in any way by reason of VLOA holding the copyrights to the original designs.". However, the VLOA would discourage the use of designs for commercial purposes and profit, except by organized groups of former members of the referenced units and detachments for the benefit of their group or membership and for other philanthropic purposes.

CHANGES MADE IN VLOA CONSTITUTION AND BYLAWS

Go back in your mind to October 2000. The place: Branson, MO. The first full reunion of the bunch of guys who were stationed in Vinh Long, Vietnam in 1964-65. We cleverly called it $\underline{R2K}$ for "Reunion 2000". Everyone in attendance (men and women) met in a room and unanimously decided they wanted to do this again and again. No one was quite sure how it would happen, but it was clear that some leadership was necessary to start pulling everything together. So, at that first meeting, three items were approved:

1) We came up with a very clever name - the Vinh Long Outlaws Association!

2) We decided, if we were going to have an "Association", we would need a

"Constitution" and some "Bylaws" to operate by.

3) Ernie Isbell was named the first VLOA Director. Planning for the future begins!

Two years pass. Now it's October 2002. We're in San Antonio for <u>R2K2</u>... (still a clever title!) The VLOA Constitution (4 pages) and Bylaws (3 pages) have been written. The sparkling new documents are presented at the membership meeting and are approved, without change, by the attendees. The VLOA is now a real organization, with a Director, Deputy Director, Secretary, Treasurer and other officers cobbled together in what we termed our "Steering Committee".

The Constitution and ByLaws seem to work. <u>**R2K4**</u> in Fort Rucker and <u>**R2K6**</u> in Pigeon Forge come and go with no apparent reason to change any of the provisions.

Then, prior to **<u>R2K8</u>** in Hershey, events begin to change. At the membership meeting, (still with the men and their ladies participating) some changes to the VLOA documents are proposed. First, a nuanced word "bi-annual" needs to be changed to "biennial". Done!

Then several members pointed out that, although we say our membership ranks are open to all Outlaws, regardless of when they served in Vietnam, our membership <u>categories</u> only provide for "Associate" membership for these Outlaws. Several individuals who fall into that category, and who have indicated a desire for VLOA membership, indicated that being an "Associate" member carries a connotation of being less than a full member. Our Constitution does not provide a logical category of membership for these Outlaws.

Therefore, a proposal is put before the membership that would define all "original" Outlaws (Aug '64 – Sep '65) as <u>Charter Members</u>, a new category.

A second, new, category – <u>General Member</u> - is proposed for all other Outlaws (and those in attached units), who wish to join the VLOA. Such members would be full members of the VLOA and, if in an "Active" status, may vote and hold office in the Association.

The proposal goes on to state that either Charter or General memberships are eligible for Life Member status upon payment of a one-time fee, already in place.

The restructuring of the membership categories in the Constitution is approved by the members by voice vote.

Then, attention turned to a couple recommended, minor changes for the ByLaws. The first was a wording change to conform to the new "Charter" and "General" membership status. The second removed the words "for-profit" from our ByLaws since our organization is registered as a "non-profit" entity. Both changes were again approved.

The changes described above will be made to both VLOA documents and will be posted accordingly on the VLOA website. Our Association documents are, indeed, living documents that change to conform to the best interests of the organization as a whole.

Prior to <u>**R2K10**</u>, the Steering Committee, headed by Frank Estes, will address several issues related to attempting to bring into the VLOA, other Outlaws from later year-groups. Frank has more on that issue elsewhere in this Newsletter.

VINH LONG OUTLAW ASSOCIATION (VLOA) 13 September 2008

The VLOA Business Meeting was held in Harrisburg, Pennsylvania in conjunction with the VLOA Roundup (R2K + 8) on September 13, 2008.

The meeting was opened by Joe Clelan, the National Director, who again welcomed all participants to the Roundup. Copies of the 23 October 2006 minutes were made available to the participants and the minutes were read to the membership.

There was no old business.

Angelo Spelios made a motion to approve the 2006Minutes and it was seconded by Ernie Isbell and approved by unanimous vote.

Charles Bouton, Treasurer, presented the financial report which contained an overview of the financial condition of the VLOA with a balance of approximately \$13,000 not including proceeds from the silent auction, the lottery, QM sales and the book sales. The biennial financial audit has not been scheduled at this time. Pat Theriot made a motion to approve the treasurers' report, and it was seconded by Tim Bisch and approved by unanimous vote.

A number of new business topics were discussed and voted on by attendees:

Frank Estes made a motion to make the following changes to the Constitution and it was seconded by Ernie Isbell and approved by unanimous vote of the membership present:

Article III. "Operation" Para: C. States that a bi-annual audit will be conducted. Bi-annual will be changed to read biennial.

Article V – Membership

A. All personnel who were affiliated in any way with the U.S. Army Air Mobile Light helicopter company designated as the 62d Aviation Company, and later redesignated as Company A, 502d Aviation Battalion, and its affiliated support units, and who served at any time between August 1964 (the date of initial activation) through September 1965 (end date of the units' first year in Vietnam are eligible for Charter Membership in the VLOA.

B. All personnel who served in the Outlaws or any affiliated unit after the unit was redesignated as the 175th Aviation Company, or any follow on unit participating in combat operations, are eligible for General Membership in the VLOA.

D. Membership classifications are: Charter, General, Active, Honorary, Associate and Life. VLOA memberships are described as follows:

- 1. "Charter Member: Any individual assigned or attached to the Outlaws or any of its attached units during the time frame August 1964 through September 1965. Such members are full members of the VLOA and, if in an 'Active' status may vote and hold office in the Association."
- 2. "General Member: Any individual assigned or attached to the Outlaw unit(s) after the period de fined as Charter Members. Such members are full members of the VLOA and if in an "Active" status may vote and hold office in the Association."
- 3. "Active Membership: no change in this definition.
- 4. "Honorary Member: no change in this definition
- 5. "Associate Member: no change in this definition
- 6. "Life Member: Life membership will be made available to an individual eligible for Charter or General membership, and who pays a one-time Life Membership fee as established by the Steering Com mittee." (Cont'd on Page 13)

Pat Theriot made a motion to make the following changes to the By Laws and it was seconded by Charles Bouton and approved by unanimous vote of the membership present:

Chapter 3-Termination of Membership. Delete the words "and the member will revert to the General membership status". Chapter 11-Quartermaster. The last sentence will be amended to read as follows: "Any revenues derived from the sale of items made available to members will be used for the benefit of the membership and for VLOA operational expenses as approved by the Steering Committee".

Joe Clelan announced that Chuck Wren is maintaining the Outlaw web site.

A discussion was held regarding the planning for future Round-Ups and a motion was made by Ernie Isbell to hire a reunion coordinator to do the planning and that the Steering Committee would select the reunion coordinator. The motion was seconded by Pat Theriot and unanimously approved by the membership present.

Joe Clelan explained the purpose of the book sale and exchange and that the proceeds would be donated to support the Fisher Houses, which are analogous to the Ronald McDonald Houses. The Fisher Houses are affiliated with DOD and Military hospitals and provide a place for families to stay while service members or dependents are hospitalized.

Al Iller made a motion to make a donation to the Fisher Houses of \$1,000.00 which would include the money made on the book sale. It was seconded by Skip Frontera and unanimously approved by the membership present.

Joe Clelan opened the discussion concerning a new director. Ernie Isbell made a motion to nominate Frank Estes as National Director and it was seconded by Tom Anderson and unanimously approved by the membership present.

Al Iller made a motion to nominate Bob Koonce as Deputy Director. It was seconded by Jim Kelly and was unanimously approved by the membership present.

Frank Estes appointed Charles Bouton to another term as Treasurer and Larry Jackson to another term as Secretary. They both accepted the appointment.

Al Iller made a motion to nominate Dave Logan as a Member-at-Large. It was seconded by Paul Martin and unanimously approved by the membership present.

Al Iller made another motion to nominate Jim Grandstaff as a Member-at-Large. It was seconded by Pat Theriot and unanimously approved by the membership present.

Frank Estes appointed Bill Hensinger to the position of Quartermaster and Bill accepted the appointment.
