



#### NATIONAL MUSEUM OF THE PACIFIC WAR / HISTORIC FREDERICKSBURG Friday, September 23

## VLOA TAX EXEMPT STATUS by Frank Estes

Sometime around the middle of 2009, we began an effort to find the documents that formed the VLOA as a nonprofit organization. After a search by all the former officers and directors we were able to find the original documents that set up the VLOA and obtained an Employe Identification Number (EIN).

However, no action had ever been taken to submit our application for IRS approval of the VLOA as a non-profit, tax-exempt organization. In turn, Tom Anderson and I began a hard-pressed effort in October 2009 to gather the necessary information and documents, and complete the application process.

This effort took between October 2009 and January 27, 2010, the date we submitted the application to the IRS for designating the VLOA as a 501(c)(19) war veterans' organization, tax-exempt status. Our request received IRS approval on April 30, 2010. Now, all your contributions and donations to and for the VLOA's use are tax exempt. However, you should discuss this matter with your tax preparer before taking the deduction.

With the Quartermaster International web page up and working, and the reunion Silent Auction coming up, please consider donating items for use on these two money-making venues. You can get a certificate of donation to use as a tax write off under "contributions or donations," and if you purchase a donated item, the same can be done. Your dues are also tax-exempt. These things help keep the VLOA financial status in a sound position.

Ann and I look forward to seeing you all in San Antonio, TX during September 22-26, 2022 at our next Outlaws Roundup.

Every two years, as autumn-time nears An announcement arrives in the newsletter or mail. "A reunion is planned; it'll be really grand; Make plans to attend without fail."

I'll never forget the first time we met; We tried so hard to impress. We drove Fancy cars, smoked big cigars, And wore our most elegant dress.

It was quire an affair; the whole Outlaws group was there. It was held at a fancy hotel. We wined, and dined, and we acted refined. And everyone thought it was swell.

At our next get-together, no one cared whether They impressed their group or not. The mood was informal, a whole lot more normal; By this time we'd all gone to pot.

In 2002, one event was held out-of-doors, at a Texas ranch:

We ate Bar-B-Que, potato salad, and beans. Then most of us took a ride on the hay, in our boots, cowboy hats, and jeans.

By the fifty-fifth year, it was abundantly clear, We were definitely over the hill. Those who weren't half dead had to crawl back to the bus.

And be back at the hotel in time for their pills.

And, now I can't wait; they've set another reunion date:

Our next reunion is coming, I'm told. It should be a ball, they've rented a hotel and a hall, At the San Antonio rest home for the old.

Repairs have been made on my hearing aid; My pacemaker's been tuned up on high. My wheel chair is oiled and my false teeth have been boiled:

And I've bought a new rope, and new knots I have learned to tie.

I'm feeling quite hearty, and I'm ready to party; I'm gon'na dance 'til dawn's early light. It'll be lots of fun, I just hope there's other Outlaws, Mavericks, Bushwhackers, Roadrunners, doorgunners, and signalers Who can make it on that glorious night.








#### The Back Pew

### Directors' and Outstanding Outlaw's Award Nominations

## A letter to the editor.



I, (Bob Sharp), received a response to a request for information for an article for the VLOA Newsletter. It piqued my interest in as how it reminded me of my experience that happened so many 50+ years ago.

My history with the Outlaws is that I served with the 11<sup>th</sup>. Air Assault Division from its inception at Ft. Benning, GA in 1963 and was assigned to the 62<sup>nd</sup> Assault Helicopter Co. and deployed in September 1964 to Vinh Long, So. Viet Nam. I was soon transferred to Soc Trang to the 121<sup>st</sup>. Aslt. Hel. Co. Home of the Soc Trang Tigers. The A/C I was assigned to was "White Tiger 9." I tell you this because I covered all of the Delta resupplying outposts, on many assault operations, and recovery missions of the wounded and the dead. We picked up soldiers, ARVN and American after the firefights. We also ferried dignitaries, high ranking officers (ARVN and American) and a Catholic Priest named Father Hoa. And there is the beginning of the article. Father Nguyen Lac Hoa. (When-Lock-Wah.)

I received a letter from a member of the VLOA and his name is Joseph J. O'Neil LTC (RET). In this letter was a print off from Wikipedia about a Catholic Priest, Father Augustine Nguyen Lac Hoa (c.1908-c.1989) He was a refugee Chinese Catholic Priest, who arrived in South Vietnam in 1959 and led a militia called the "Sea Swallows" resisting the Viet Cong in the Ca Mau Peninsula. The "fighting priest" and his "village that refused to die" attracted admiring media stories in the United States, and in 1964 he received the Ramon Magsaysay Award in the Public Service category.

Father Hoa fled from Kwangsi Province in Communist China in 1950/51 with over 2,000 parishioners and spent eight years in Cambodia. In 1959 Hoa, with 450 of the refugees settled in Binh Hung on the Ca Mau Peninsula. (Pg.1)

(Cont. from Pg.1) They created a village and Hoa established a defense force -the Sea Swallows- against the Viet Cong who were active in the area.

Father Hoa's success inspired others to join his Sea Swallows, including a company of "Nung tribesmen." Declassified documents would reveal that the Nung fighters were actually a contingent of the Nationalist soldiers from the Republic of China.

As the political situation in Saigon deteriorated, Father Hoa saw the battle turning and little chance of winning. Discouraged, he left Binh Hung, and retired to a parish in Taipei.

(Back to the letter from Mr. O'Neil.) Dear Robert-

In the latest Outlaws Newsletter, there was a request for information. I came across this story after looking up "Father Hoa" from memory. On my second tour in Vietnam, I ended up as Outlaw 5 when my predecessor, Charles R. Latta, was killed in amid-air near Saigon. I rotated on 30 January 68, and my replacement, James Vrba, was killed at Vinh Long the first night of the Tet Offensive. I hadn't even reached the US yet.

On my first tour I was stationed in Soc Trang (62&63). My unit was attached to the 93rd. Trans. Co., which later became the 121st AHC (Soc Trang Tigers). Since I was not rated in the CH-21c, the only flying I did was in the O-1's, but they were used quite a bit for C&C, vectoring and observation.

We had quite a few missions for the 93<sup>rd</sup> going into support "Father Hoa", which must be why I remembered the name. I never got to land there as it was a heliport although I did hear that a few fixed wing aircraft did get in and out ok. (Pg.2)

(Cont. From Pg.2) I treasure my "Sea Swallow" pin which most of the aviators at Soc Trang wore. The story was, if you went down anywhere near in the Ca Mau Peninsula, the pin might get you back to safety at Father Hoa's.

### Thank you. Joseph J. O'Neil

Well, that stirred my memories and I jumped up and ran down to my office and dug out a picture I knew I had of Father Hoa as we shuttled him to Saigon and back different times, and he had an advisor with him, and I believe his name was Sgt. Bergeron. I also have the cap that I wore then, it has my "Sea Swallow" pins on it and I took some pictures that I will post. (Pg.3)



Well, needless to say I had to respond and I wrote him a letter and sent pictures of my cap with my pins and told him my story about hauling Father Hoa around. He responded with another letter full of information that I thought was interesting.

He said that he had come to Vietnam in 1962 as the Ex. Off. of the 18th Avn. Operating Det. We deployed from Okinawa on an LST and spent almost two weeks getting to Soc Trang. We unloaded from the ship near the village of Dai Ngai - east of SocTrang. We road marched by vehicle (about 45 men and 15 vehicles), our job was to operate the tower, flight operations and refueling at Soc Trang. I commanded the unit from Okinawa to Soc Trang. The unit commander flew ahead as I believe he wasn't thrilled with spending 2 weeks on a LST. I was helicopter qualified but not on the H-21, so I flew it very little. One of the H-21 pilots gave me my Sea Swallow pin and everyone wore them proudly. I flew a large number recons in the Ca Mau and Rach Gia area.

On my second tour (Jan 67-68) I was stationed in Sadec for a while as the liaison officer (Delta 9) to the Ninth ARVN Div. I was then called to Vinh Long as the XO of the 175th AHC. I filled in until the new Cmdr. arrived. I was his junior and I flew with him for some time until he was accustomed to the country. Like I said before, I left Vietnam for home on January 30th, 1968 exactly 1 year to the day of my arrival and my replacement was killed the first night of TET.

On a personal note: My first wife and the mother of our six children, died of a massive heart attach on Feb 28, 1968 while I was going thru O-21 IP school at Fort Rucker. She died in the Ft. Rucker Hospital. I was enroute to Okinawa upon completion of the course but couldn't complete the course. So I took the six kids (a couple of the littlest barely knew me as I had been gone for a year) and went to Okinawa to be the OPS Officer at the airfield there.

(Cont from Pg.4) About a year later, I was corresponding with a widow whose husband that was stationed with me at Ft. Hood. He was killed in an OV-1 Mowhawk in Germany in 1962. He is buried in Arlington near the Kennedy's graves. She had 5 children—we got married in Pennsylvania on January 25, 1969. I took her and her 5 kids to Okinawa to join up with my six so we had 11 children and the oldest was 12! Subsequently, we had a boy and a girl later to add to the crowd. So now we have 13 children, 29 grandchildren, and 9 great grandchildren.

Right now she is struggling with stage 4 breast cancer and COPD and as you can imagine the outlook is not good.

We have had 53 years together, a great marriage, and a great family. We have to focus on taking care of each other every day.

Thanks again for your letters and hope you can read this.



After retiring from the Army, Ike worked for many years as a Realtor alongside his wife. When not busy with work he enjoyed traveling, playing golf and spending time with family.


