## National Director's Corner

Greetings to all Outlaws, Mavericks, Roadrunners, 28th Avionics Sig Det. B Troop 1-158th Outlaw Aviation and 175th Bushwhackers.

I'm sure that most of you will agree with me that this winter has been the worst in recent memory for most of us. Spring has finally arrived so we can look forward to warmer days and no snow. By the time that you are reading this, Polly and I will have returned from our trip to South Africa. We have 19 friends and neighbors from Port Royal Plantation that will be accompanying us on the trip. We have a direct flight from Atlanta, GA to Johannesburg lasting 15 ½ hours and covering 8434 miles. We will visit Mpumalanga, Kruger National Park (where we will have 3 game drives), Mbabane, Swaziland; Hluhluwe, Durban, Port Elizabeth, Knysna and Cape Town. Our return flights will be from Cape Town to Paris and then on to Atlanta. This trip should be quite an experience and I'll share some of the highlights in a future newsletter.

I expect to have a final Request for Proposal (RFP) for our reunion requirements that will be sent to a number of reunion planners in the Branson area completed by the end of April. I will require that preliminary proposals be submitted by mid-July so that a decision can be made by mid-August prior to my visit to the area. I plan on meeting with the selected reunion planner to review the plan. The reunion planner will be required to submit detailed cost data so that we can have a registration form with final costs that will be published in the January 2016 newsletter and will be posted on the VLOA web site.

I wanted to share with you a synopsis of my life from the time I arrived at Vinh Long until the present. I know some of you probably know this but humor me so I can share it with everyone else.

I was assigned to A Company, 502nd Avn. Battalion (Outlaws) in June

1965. I joined the Maverick platoon in August prior to the unit being sent to Cam Ranh Bay to train a Brigade of the 101st Airborne Division in airmobile operations.

I returned to the states in June 1966 and was assigned as an instructor pilot at Fort Wolters, TX. I was an instructor in the Primary phase of training in the OH-23 and TH-55. I received a direct commission as a 2nd Lieutenant in June 1967 and attended the Armor Officer Basic Course at Fort Knox, KY and Cobra Helicopter transition training at Hunter Army Airfield in Savannah before returning to Vietnam for my 2nd tour.

I was assigned to A Troop, 3/17 Air Cavalry Squadron at Long Binh, VN. When I arrived, the unit had not received their Cobras so I was transitioned into the UH-1C gunship. The Silver Spurs were supporting the 199th Inf. Bd. and the 52nd LRP Company in interdiction missions on routes into the Beinh Hoa and Saigon area. I was assigned as the Troop maintenance Officer when the Reserve Captain who came over with the maintenance unit rotated home. I think that this assignment was probably the hardest assignment I experienced during my 20 years in the Army. We had very few days that we did not have at least one of our helicopters with bullet damage so it was very hard to keep enough ships flying to support the mission.

Upon my return, I was then selected to attend college full-time and received a BBA in Economics from Armstrong State College in Savannah, GA in 1971. I was then transferred to Fort Knox and was assigned to a Training Battalion. I spent a year commanding a training company training Radio Operators. I was then the Operations Officer for the Battalion which trained Radio Operators and Cooks. I then attended the Advanced Armor Office Course at Fort Knox, KY and attended night school and earned a Master of Science in Systems Management/Information Systems from the University of Southern California in 1974. I was then transferred to Fort Hood, TX where I served in A Troop, 2/1 Cavalry Squadron as a scout platoon leader and operations office. I was tasked to run the 2nd Armored Division Museum for 6 months. This was an interesting assignment as I had to work very closely with MG George S. Patton Jr. as he wanted the focus of the museum to change from his father and Elvis Presley and to reflect the Divisions roles in WWII, I was then assigned to the 13th COSCOM to Command the 13th Data Processing Unit which provided the automated logistical and personnel support for 3rd Corps. I was promoted to Major in February 1978 and was then transferred to the Military Personnel Center in Alexandria, VA where I managed the Personnel Structure and Authorizations data base. I retired in October 1982.

I then worked for two civilian companies in the Northern Virginia area supporting the National Intelligence Community in developing automated systems used to collect and distribute intelligence data. My area of expertise was computer communications and I was able to travel extensively all over the world. I loved my work but after 22 years of commuting in the Washington, D.C. area I decided to call it quits and try retirement. My wife of 50 years, Polly and I moved to Hilton Head Island, SC in September 2000 where we enjoy playing a lot of golf and walking on the beach. Polly is a Pediatric RN and she enjoys working at the Volunteers in Medicine Clinic here on the island. They provide free medical care to workers

Cont. from pg.2 and residents here that have no medical insurance and a limited income. I play golf 4-5 days a week and enjoy working in the yard. I have served as President of the Board of Governors of our Golf and Racquet Club, as the Golf Chairman of our club, and as Captain of our Low country Interclub team. I have served as Secretary for the VLOA for the 12 years.

We enjoy traveling, especially cruising. We have traveled to New Zealand and Australia, a River Cruise in Europe from Amsterdam to Budapest, Hungary; Alaska, French Polynesia, Hawaii, Scandinavia and St. Petersburg, Russia; the Caribbean, the Mediterranean, sailing through the Panama Canal and down the West coast of South America to Valparaiso and Santiago, Chile. We have also toured Thailand, Cambodia, Israel, Egypt, China, Vietnam, Singapore, Italy and Sicily, Ireland and cruised around the Greek Islands, Dubrovnik, Croatia and Istanbul, Turkey.

We also visit Texas and Denver a couple of times each year to visit our families. We have two adult children, Greg who lives on Hilton Head and Katy who lives in Charlotte, NC.

Finally, a note about what is going on in my life. I have been diagnosed with a leaking mitral valve in my heart. Polly and I will be leaving May 10th to drive to Weston, Fl. I will have surgery on May 13th at The Cleveland Clinic Hospital Cardiac Unit. They expect that I'll be in the hospital 3-5 days and then I must stay around for a few days for my check-up in order to release me.

I wish every one of you a pleasant spring with family and friends.

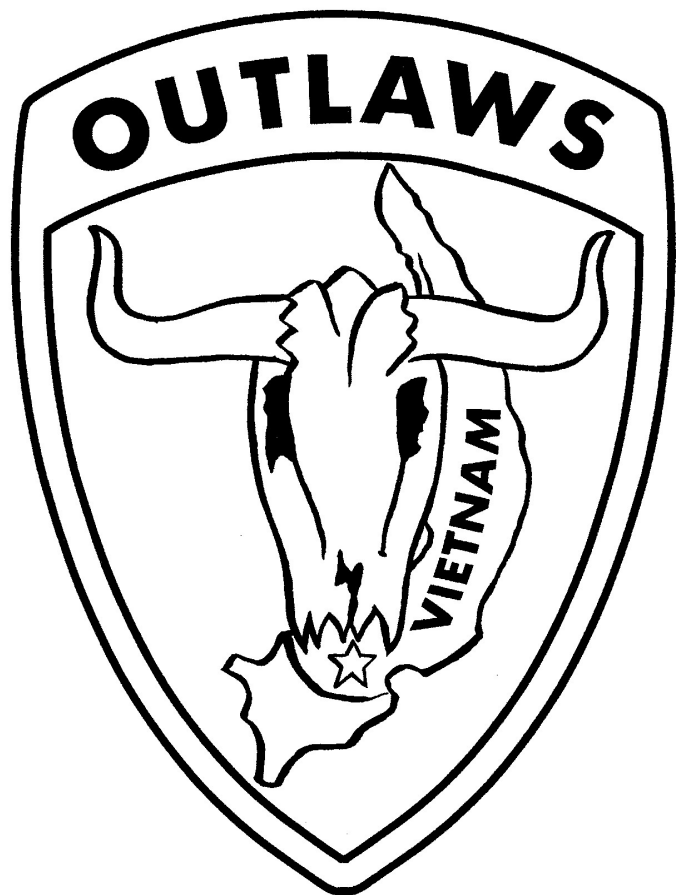
**LOST OUTLAWS**

**VIET NAM HELICOPTER PILOT AND CREWMEMBER MEMORIAL**  
**AT ARLINGTON NATIONAL CEMETERY**

The Viet Nam Helicopter Pilots Association (VHPA) is currently undertaking a long-overdue project to have a Viet Nam Helicopter Pilot and Crewmember Memorial placed in Arlington National Cemetery (ANC). The Memorial will honor all helicopter crewmembers, of all ranks and branches of service, who gave their lives in service to their country while engaged in helicopter operations in Viet Nam.

It is a well accepted fact that helicopters were the backbone of the Viet Nam war effort. Without the helicopter, our forces could not have had the successes that were accomplished on the battlefields of that war. And, it is also recognized that hundreds of helicopter crewmembers were lost during the Viet Nam conflict.

There can be no more appropriate, logical or rightful location for a memorial to helicopter crewmembers than Arlington National Cemetery. Nearly 20% of the 2590 Viet Nam KIAs buried in Arlington National Cemetery died while serving in rotary wing aircraft. Statistics show that approximately 10% of the more than 58,000 killed in Viet Nam served in helicopter units. Nearly 5000 helicopter crewmen were KIA in Viet Nam. Arlington is also the final resting place for a number of MIA helicopter crews recovered after the war, and interred in common grave sites.

We all know that Viet Nam veteran's organizations, such as the VLOA, are, in fact, a "Last Man" club. We are poignantly aware that World War II veterans are becoming fewer and fewer. Korean War vets have also reached their senior years. And, it is undeniable that all of us Viet Nam veterans are also on our way to becoming memories.

The VHPA is deeply concerned that no national monument exists to honor helicopter crewmembers who gave the supreme sacrifice in the Viet Nam conflict and that the sacrifices of these men will soon fade into history. When that day arrives, there would be no individual or organization to spearhead an effort to sponsor such a memorial. Therefore, the VHPA initiative is focused on putting in place a memorial which will forever recognize, and honor, the sacrifice of helicopter crewmember of all ranks and all branches of the US military services. Now is the time!

However, obtaining approval to erect the Memorial monument at Arlington is proving to be a daunting task. The process began in September 2014 when the VHPA delivered a complete memorial package proposal to ANC. At that time the VHPA was led to believe that the approval process could be completed in time to plan for a dedication ceremony on August 28, 2015, during the annual convention of the organization in Washington DC.

The application review process began with a formal presentation to a Subcommittee of the ANC Advisory Committee in March 2015. With that group's recommendation, a complete presentation was made to the full Advisory Committee for their review. That presentation included a full outline of the proposal with justifications and suggested locations within ANC. Upon approval, the proposal must then be forwarded to the US Commission of Fine Arts for their review and decision.

Assuming approval by that body, the proposal is forwarded to the Secretary of the Army who is required by law to notify the US Congress for information and comment. After a 60 day filing and review period, the Secretary of the Army will make the final decision whether the VPCM Memorial is placed within ANC. That decision must be made with consideration of the limited burial space within the cemetery.

The VHPA will be soon notify, and invite, ALL Vietnam-era helicopter pilots and crewmembers, and their families, to attend the memorial service at the Arlington National Cemetery Memorial Amphitheater 10:00 AM, August 28<sup>th</sup>, 2015. Recognizing the potential for bureaucratic delays, it is possible that approval, construction and installation of the memorial may not be completed by the hoped-for date of 28 August. In that event, VHPA President Bob Hesselbein has stated that the Arlington Cemetery ceremony on that date will be marked with a tree planting ceremony, which has previously been approved with the Memorial to be dedicated at a later date.. The tree has been generously donated by the VHPA Old Dominion Chapter.

This Viet Nam Pilot and Crewmember Memorial will be the last mission that can be performed to truly honor our lost brothers-in-arms. The humble VPCM memorial will far outlive all of us and will serve as a lasting reminder of the valor and sacrifice of our generation to those who follow.

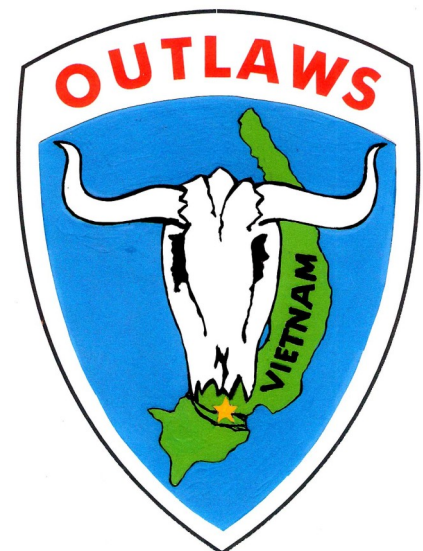

The reverse side shows a US flag with the words **VINH LONG VIETNAM** on the outer edge with the name **OUTLAWS** superimposed on the US flag.

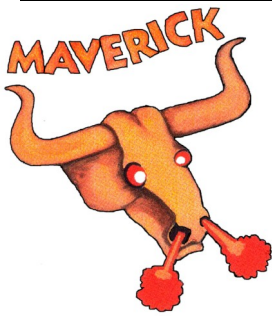

Because the entire original order was either distributed or sold during the reunion, an additional order of coins was ordered and has been received. Nearly half of the re-order has already been spoken for.

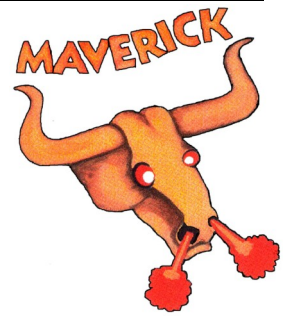

These coins will go fast. The manufacturer indicates that the die is normally destroyed after one year so this may be the only opportunity to pick up those additional coins you wanted. Because there are no restrictions on who can purchase the coins, it is possible that outsider Challenge Coin collectors, seeing the ad on the Outlaw web site, may buy up a number of the reordered coins. ## Proud of Continued Family Military Service

Having completed over 29 years of active duty service I chose to retire September 30, 1986.

I was pleased my oldest son Frederick (Fred) would be present for the occasion. Fred joined the Army Dental Corps in 1985 immediately upon graduation from the University of Alabama School of Dentistry. He had just finished a one-year Advanced General Dentistry residency at Fort Bragg, NC and was headed to Mainz, Germany. Almost 29 years later Mitzi and I will be proud attendees for his retirement ceremonies at Fort Gordon, GA to acknowledge his official retirement after 30 years of military service. In addition to performing the usual dentistry services, after his specialty training in periodontics he spent the majority of his Army time in dental education (over 15 years). From 2000-2004 he was the periodontal mentor with the Army Advanced Education in General Dentistry 12-month Program at Baumholder, Germany. He returned to Fort Gordon for assignment with the U.S. Army Advanced Education Program in Periodontics, first as Assistant Program Director from 2004-2007 and then as Program Director from 2007 until present, three years longer than anyone previous. His residents earned board certification at record rates; they won numerous research awards, and the Army Program earned a place as truly one of the best periodontal programs in the country. In addition to regularly scheduled periodontics residency courses. Fred helped to train numerous Army dentists in periodontics by traveling to various venues and speaking about periodontics.

Since 2010 he has provided approximately 300 hours of continuing education courses to both Army and civilian dentists alike. He served as Periodontal Consultant to the Surgeon General since 2010. He has received numerous Army and national awards for his periodontics service to include the 2014 Dental Corps Chief's Award for Excellence in Dental Education,

Another highlight of his retirement ceremony will be attendance of his son 1/LT Frederick (Travis) Bisch, U.S. Army Transportation Corps. ## *Outlaw Website's New Look*

Our website host, Harlow Media and I have been working since the reunion to arrive at an agreement on what our website

upgrade will include to bring it into the modern era. The following will briefly explain what the upgrade entails.

Keep the patriotic theme and all logos on the home page, with the Outlaw logo predominant at the top left of the page.

The menu currently at the left of the page will be moved to show up across the top of the page with dropdown submenus to see subpages on the main pages. Redesign the Home Page with some new gee-whiz stuff, and link it to Facebook and Twitter so we can just grab things located there and post them on the home page. Move six other logos to one of three potential positions on the Home Page to make the page more presentable. Move the Links Page to the bottom of the Home Page and add "Contacts" link (for National President, Newsletter Editor, and Website Manager (email addresses only)) also at the bottom of the Home Page; these two items will be seen by clicking on "Links" or "Contacts." This will eliminate one page in the main menu. Consolidate Honor Roll Page and Chaplain Page as sub-pages under the Membership Page, thereby eliminating two pages in the main menu. Consolidate Constitution/By Laws, all current History subpages, and Then & Now Page under the History Page, thereby eliminating two pages in the main menu. Rename Gallery Page as Photo Gallery Page.

Keep Guestbook Page as current. Keep Feedback Page as current.

Put "Newsletters Page" on the Home Page with a "link" to get to the newsletters, thereby eliminating one of the main pages in the main menu. Program the website to be compatible with smart phones and tablets so that all you have to do is scroll down and not have to shrink/expand the size of the viewed page. Keep all current content in reformatted form, and decide over time if it needs to be modified, shown in a different place, or expanded to make better sense.

Develop a 1-hour DVD of how to manage the website, including how to make changes to all pages, subpages, modules, and sections. This will be very useful when I turn the website over to someone else, making it easy for the new Website Manager to get up to speed on keeping the website updated.

In closing, the plan calls for Harlow Media to have all the coding accomplished by mid-April and the new-look website online by the end of May; hopefully sooner. After the first "new" version is developed, there will still be a lot of tweaking require to ensure we do not lose information currently contained on our website. If you have been watching, our website is close to breaking 200,000 visits since our website went on line in late 2008. Not bad; not bad at all.



## Ireland– 2014

Polly and I started our tour of Ireland in Dublin in August, 2014.

We were travelling with our friends, Peter and Polly Hopkinson. Our first stop was for 2 nights in the Shelbourne Dublin which dated back to 1824. The Shelbourne is one of the most famous hotels in Dublin -- indeed in Ireland -- and its icon status is immediately clear from the moment guests arrive. St. Stephen's Green is one of the most popular (and crowded) tourist areas in the city center, and The Shelburne's stately brick facade, colonnaded entrance, intricate wrought iron fence, and door-men with top hats draw plenty of attention.

We started our visit in Dublin at the Trinity College founded by charter of Queen Elizabeth in 1592. The library is one of the world's great research libraries, holding the largest collection of manuscripts and printed books in Ireland. One of the highlights was the viewing the Book of Kells which was written over 1,000 years ago when Ireland had a population of less than a half million people. The Book of Kells contains lavishly decorated copy, in Latin, of the four gospels. It has long been associated with St. Colum Cille (c. 521-597 AD) who founded his principal monastery on the Island of Iona. We also visited the Guinness Storehouse located in the heart of the Guinness Brewery at St. James Gate (founded over 250 years ago). You walk through the door into the building's giant, pint-shaped heart of glass visitors' center. The highlight of the tour was having a pint in the 7th floor tasting room with a 360 degree view of Dublin.

Our next stop was in the historic city of Waterford where we visited the House of Waterford Crystal. We took a tour of the fascinating factory where we were able to see how the crystal was molded and finished into beautiful designs. The tour ended in the retail store which houses the largest collection of Waterford Crystal in the world.

The next day we journeyed to the historic Blarney Castle. It was a rugged climb to the top on a narrow spiral staircase where you had the opportunity to kiss the famous Blarney Stone. I passed on this opportunity but Polly agreed to be put in position for the kiss but decided not to put her lips where thousands of others had already done the deed. We continued on from there to Killarney where we were treated to a jaunting car ride\* (a horse drawn cart) over to the Muckross House and Gardens. A tour of the house and gardens offered a glimpse into the elegant life-style of the Victorian gentry.

The following day we traveled along one of the most beautiful coastal routes in the world, the Ring of Kerry.

We enjoyed pristine ocean scenery as we went through picturesque villages. We climbed up rugged mountain passes into “Ladies View” where we were able to gaze upon the Lakes of Killarney.

The next morning we left Killarney and our first stop was at the Molanna Dairy Farm. We visited with our hosts, Paddy and Margaret Fenton as they talked about the workings of an Irish Dairy Farm. Paddy was born in a small home dating back to the 1600’s. Their modern farm house where they raised their family is now operated as a B & B. We continued on to Limerick, where we spent the night.

On Sunday we journeyed to the stunning, 700-foot high, Cliffs of Moher. It was a long walk to the edge of the cliffs but was worth the effort as we had awe-inspiring views of the mighty Atlantic and the Aran Islands. You had to work hard to stand up to the strong winds coming off the ocean. We continued our day travelling through the vast limestone landscape of the Burren, known for its stark beauty and Neolithic tombs.

We started the next day with a cross-country journey to Irish Whiskey territory. We visited the Tullamore Dew visitors’ center for a tour of the distillery and explanations of how the whiskey was brewed. Following the tour, we were treated to tastings of several of their whiskeys. We continued on to Kingscourt and the Cabra Castle, where we spent our last night in Ireland. The original Cabra Castle, the ruins of which still stand on high ground in Dun na Ri Forest Park. The Castle and the land surrounding it belonged to the O’Reilly Family until it was confiscated in the mid 17th century by Cromwell’s orders and given to Colonel Thomas Cooch. It remained in the family for the next 265 years but was disposed of in 1964 because of economic circumstances. In 1991, the castle was purchased by its present owners, the Corscadden family, who re-opened it as a hotel. Since then the property has been extensively refurbished and expanded from 22 bedrooms, to incorporate the former courtyard area, Gate Lodge and 6 newly built Cottages. We stayed in what was originally the milking parlor.

We enjoyed really great weather with only a couple of days of light rain and very warm for that time of year. The country side is beautiful with homes and there carefully manicured yards. Much of Ireland is farm land and everything is bright green. The people are very outgoing and friendly. *Larry Jackson.*

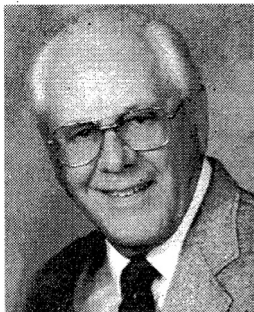

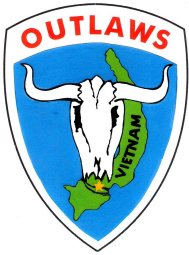
