Themed after the majestic showboats of the 1800s, the Showboat Branson Belle evokes the spirit of a bygone era when river boat adventure, glamorous travel and dazzling entertainment converged into what we remember as Those Grand Old Showboatin' Days!

The Showboat Branson Belle was launched from her lake side shipyard August 13, 1994, using two tons of bananas as a lubricant for the nine second slide into the water. She traveled 14 mph during the launch, faster than she'll ever travel on water.

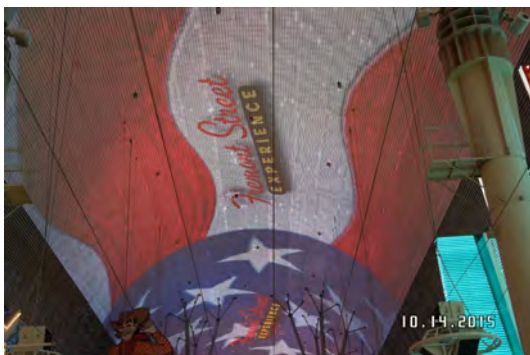

From Gunships to The Pulpit

John Doyle has asked to be retired from his duties as VLOA Chaplain. John is one of the early VLOA members, back before the Association was even formed and has served as our Chaplain since 2000. Those of us who knew the tough-talking, take-no-prisoners, Maverick Platoon Sergeant back in 1964-65 would never have predicted his choice of a second career.

John served three aviation tours in Viet Nam (Vinh Long, Phu Loi and Phu-Bai- Hue) before being medically retired from the Army in 1970 as a 1st Sgt, E-8. After leaving the Army, John received his degree from, Austin Peay State University and worked in environmental services until he answered God's call to the ministry. He graduated from the Master of Divinity program at the Baptist Theological Seminary at Wake Forest, NC. He then pastored several churches in North Carolina and served as an Evangelist minister. He also accepted an invitation from the 1st International Baptist Church in Copenhagen, Denmark to serve as an interim Pastor for a six-month period. He then retired again in 1997.

John's legacy as a Maverick was firmly established with an innovative solution to a potentially lethal combat mishap. In those early days in Viet Nam, side-door gunners had to physically hold their machine guns with no other support. Later we went to a bungee, and then to pintle mounts. However, being hand-held, door gunners had a wide range of traverse with the machine gun. On a break, and in the excitement of the mission, the gunners could continue to fire as long as they had a target, with nothing to limit the gun from potentially firing into the back of the front cockpit seat. Because gunships normally had no use for litter poles, John improvised a solution by installing a litter pole in the doorway behind the front seat, which prevented the gunner from inadvertently firing into the front cockpit. His technique was quickly adopted by all Maverick ships as well as other gun ships in the Delta. He was presented with a mounted Doyle Pole award at the VLOA planning meeting in Pigeon Forge, TN in 1999.

John has served on the Steering Committee for over 15 years. He has regularly contributed motivational thoughts and messages through his "Back Pew" articles in the VLOA Newsletter. Moreover, John has traditionally conducted an inspirational, non-denominational, service on the Sunday mornings of our Outlaw reunions.

The Steering Committee has regrettfully accepted his request to be released from his duties as the VLOA Chaplain.

To continue to provide spiritual inspiration to the VLOA membership, Paul Martin (the Arkansas Paul Martin) has agreed to accept a "TDY" tour as the next Chaplain. Paul was a slick pilot in 1964-'65 and is also an ordained Baptist minister. Paul will continue the wonderful tradition of having our own, in-house, Chaplain.

Thank you, John Doyle, for you're many years of dedicated service to the Association. And, a warm welcome to Paul Martin as he assumes the responsibilities of the VLOA Chaplain.

Directors' and Outstanding Outlaw's Award Nominations

The VLOA has an established awards program to recognize those individuals who have contributed significantly to the VLOA organization. Each of these awards has certain criteria which must be met to receive either of the awards.



Directors' Award: This award is the highest award the VLOA gives during any reunion year. This award is not an award that must be mandatorily presented at each biennial reunion. Only one of these awards may be given because it is to clearly recognize the one individual or couple who has made the greatest contribution to the VLOA organization over an extended period of time. The Directors' Award is reserved for any member or couple who gives substantial, quantifiable, long-term support to the VLOA through his/her contributions, time, energies, ideas, and accomplishments in promoting and furthering the aims and goals of the VLOA as a war veterans, not for profit organization.

Outstanding Outlaw Award: For those nominees whose contribution does not rise to the level of the Directors' Award, the Outstanding Outlaw Award may be given when a nominee has given service to the VLOA, such as meaningfully holding an officer/director's position and rendered recognizably important service concerning the furtherance of the VLOA's goals, objectives, history documentation, membership location, and preservation of the organization.

Of particular interest should be the reasons that make the nominee worthy of receiving this award such as service to the VLOA, service to veterans or civic organizations, including positions of leadership or support in any of the activities being used to support the nomination.

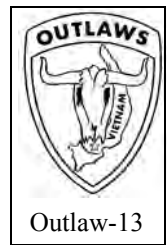


Inductee CWO-5 Edmund (Ned) W. Hubbard III in the center, on the left is J.P.Klink, and on the right is Ivey Miller.

2015 Army Aviation Hall of Fame Inductee

Chief Warrant Officer Five Edmund W. Hubard III (Outlaw 13)



CW5 Ned Hubard's 31-year career in Army Aviation combined a unique mix of operational, research and development, and command and staff assignments with over 20 years in special mission units (SMUs), flying an amazingly diverse range of aircraft from UH-1s in Vietnam to piloting the first mission into Afghanistan in a Russian Mi-17. In fact, Hubard has over 13,000 flying hours in over 150 types of aircraft and helicopters, is basic airborne qualified and trained as a high-altitude-low-opening / high-altitude-high-opening (HALO/HAHO) jumper.

In the early 1980s, following the failed DESERT ONE Iranian hostage rescue mission, Hubard was recruited into Operation HONEY BADGER, the second Iranian hostage rescue mission, making him a "plank holder" in what would become the famed 160th Special Operations Aviation Regiment (Airborne).

Following the release of the hostages, he was nominated to serve in a newly created aviation unit doing research and development. He spent the rest of his career developing concepts for unique aviation systems and missions. Many of the helicopter and mission equipment packages that are in use today by conventional Army Aviation were developed and tested by Ned Hubard in combat.

Retiring in 2000, Hubard, as a civilian, continued to support Army Aviation and ground forces, flying the first U.S.-piloted helicopter, as part of the Jawbreaker team in Afghanistan, two weeks after the terrorist attacks of 9/11.

No warrant officer has done more for Army Aviation, operationally, tactically, and technically than CW5 Ned Hubard. He epitomizes the quiet professional and warrior and is truly 'Above the Best.'

Why Everyone Pays the Same Reunion Costs

2016

An Outlaw reunion has always been the high point of the year for many of us. But, just how does the reunion get off the ground? Obviously, planning has to begin well over a year prior to the opening evening of the reunion. A location has to be set. A tentative agenda must be developed. A cost-per-person must be arrived at a year ahead of time. To do this is not easy! Here's how the final cost is determined.

With an objective of keeping the cost-per-person at a level comfortable for everyone, the planner has to begin with basically two questions: What will prices be a year from now? What has to be included in the total cost? Development of the total cost must include such items as: dinners, lunches, menus, hotel rooms, banners, transportation, tour venues, welcome bags, recognition awards, signage, special requirements, keepsake items, hospitality room, memorials, printing, gratuities, name badges, refreshments and entertainment to name just a few.

The planner makes a list of all the items that will cost money, makes a best-guess estimate of what each of those items will cost and then totals all the known costs. Then, an educated guess has to be made of how many attendees are likely to attend. That is the hardest factor to come up with. Let's say the planning committee estimates that 100 persons will attend. The estimated total cost is then divided by the hoped-for 100 attendees and an initial cost-per-person is arrived at.

Every reunion has additional unplanned costs that are incurred after the final per-person cost is determined and put on the Registration Form. These costs can be relatively substantial but are too late to be added to the initial registration fee. The VLOA treasury covers all such costs.

Many organization's reunions are structured to allow attendees to select what parts of the reunion they would like to participate in. Each component part has a separate cost. Attendees can then either pay the total price of the reunion or pick and choose what they want to participate in. Outlaw reunions are not structured to allow a cafeteria approach to each event. The Outlaw reunion is designed to allow everyone to enjoy, and participate in, all events, meals, venues, etc. together.

At each reunion, the planning committee receives requests from individuals who would like to stay somewhere else near the reunion vicinity but not have to pay the cost for hotel rooms. Specific costs for not staying in the hotel are difficult to separate out. In the same way, costs for meals or other specific costs for the many ancillary items outlined above cannot be separated. These requests are handled on a case-by-case basis by the National Director and the Reunion Planner/Coordinator. In such cases, registrants may be permitted to stay outside the reunion headquarters hotel but must purchase the remainder of the reunion package at a cost determined by the National Director and the Reunion Planner/Coordinator.

In the same manner, Hospitality Room costs are paid for by all attendees as part of their registration fee. For that reason, it is not appropriate, or fair to the attendees who have paid their registration fees, to permit "drop-ins" to participate in Hospitality Room provisions.

The personal bonding between old friends and comrades, which is the hallmark of our reunions, cannot be overstated. The reunion premise of "One Price Fits All" has been validated after 8 successful reunions and regularly supported by those who attend the reunion.

Proposed Changes to Steering Committee Composition

Over the past two years, the VLOA organization has grown significantly in the numbers of “lost Outlaws” the Steering Committee has been able to find.

Jim Donnelly, Deputy Director and VLOA Historian, has been Herculean in his efforts to target “lost Outlaws” and make contact with them. Because of his efforts, and supported by Doug Wilson, our VLOA roster has grown to nearly 500. This brings into question the need to consider changes to our Steering Committee to ensure we have representation of all year-groups from 1964-1972 while the Outlaws were in Viet Nam and 1972-1975 while the Outlaws were assigned to Germany.

The current VLOA Constitution, “Article VI – Organization” provides for Two Directors-at-Large to represent all year-groups. With the growth in number of registered Outlaws, it seems to make sense that the number of Directors-at-Large should be revisited, with the view of providing representation by year-groups. Therefore, I propose that a change be made to the VLOA Constitution as follows:

Change VLOA Constitution Section VI to delete:
Two Directors-at-Large

Change VLOA Constitution Section VI to add:
Five Directors-at-Large: one each from year-groups 1964-65, 1966-67, 1968-69, 1970-71, and 1972-75. (Should no one accept from any specific year-group, the Steering Committee will appoint someone to fill that position.)

Any proposed change to the VLOA Constitution must be announced to the membership and then voted on at the next Biennial Outlaw Reunion.

Therefore, this and possibly other changes to the VLOA Constitution and By-Laws will be presented to our VLOA Business Meeting to be held on Saturday September 17, 2016 during our Branson, MO reunion.

Wearing of Military Awards With Civilian Clothes

It is permissible for veterans and retirees to wear military awards on civilian clothes for gatherings of a military theme. On significant holidays, veterans and retirees are encouraged to wear their awards and medals. The choice of either full-size medal or miniature is an individual one.

Retired personnel and former members of the military may wear all categories of medals on appropriate civilian clothing. This includes clothes designed for veteran and patriotic organizations. The medals may be worn on:

- Veteran's Day
- Memorial Day
- Armed Forces Day
- formal occasions of ceremony
- social functions of a military nature.

Personnel may wear either full-sized or miniature medals. Personnel who wear medals on civilian clothes should place the medals on the clothing in approximately the same location and in the same manner as for the uniform, so they look similar to medals worn on the uniform.
