OUTLAWS REUNION FORMAT

The purpose of this article is to inform our membership of the history behind and rationale for conducting our Outlaws reunions the way we do. The length of this article is necessary to respond to comments about and questions why it can't be done differently. Our experience and rationale in conducting reunions is documented in our Policy Files, but the following will highlight a few important points of policy and interest.

By way of background, the first Outlaws reunion resulted from nearly two years of searching by a handful of original Outlaws for former soldiers who deployed with the 62nd Aviation Company to Vietnam in September 1964, and those who served with the Outlaws during 1964 and 1965. This was to be a "one-time only" reunion with the purpose of renewing the friendships and camaraderie formed in the Outlaws while serving together in an armed combat environment.

Al Iller and a Steering Committee coordinated and conducted the very first Outlaws reunion in Branson, MO (2000). The Steering Committee planned each of the next three Reunions by visiting the reunion site a year in advance and finalized the schedule of events. Since this required the Steering Committee members to actually attend a reunion every year at their expense, the practice was dropped. The following years saw all the planning/scheduling efforts being accomplished via Steering Committee emails after the Membership's selection of the reunion site during the biennial reunion.

My wife and I coordinated and conducted two reunions, one at Fort Rucker, AL (2004 – 40th Anniversary of Outlaws deployment to Vietnam) and one in Nashville, TN (2010). Tom Anderson coordinated and conducted two reunions; one in Pigeon Forge, TN (2006) and one in Washington D.C. (2014 – 50th Anniversary). This collective experience provided an intimate knowledge of the inner workings of a successful reunion.

We learned early on that 3-day reunions (Thursday afternoon arrival and Sunday afternoon departure) did not provide enough time for mingling, venues, meals, business meeting, and important rest breaks especially for the aging and those running the reunions. So, we changed to a 4-day reunion by a Thursday afternoon arrival and

Monday morning departure, with a slightly less tiresome schedule, more time for socializing, mingling, meals, free- or on-your-own time, personal touring and dining, and popular venues that attendees would enjoy.

During the reunion's Business Meeting, the Membership determined the reunion site. Then the Steering Committee did all the initial planning, scheduling, and handed it off to an Outlaws member in the city near the site to administer the rest of the reunion. As we became wiser, we found it better for our size reunions to hire a Reunion Planner/Coordinator familiar with the selected site, available venues, and local administrative support.

Over the years, we have quite often discussed the desire of a few Outlaws to be able to pick and choose what parts of the reunions they want to participate in, and have found no easy way to permit attendees to pick and choose as the Vietnam Helicopter Pilots Association (VHPA) does. The VHPA has an enormous staff who can select, plan, coordinate, track, and control all aspects of a very large reunion where there are literally hundreds of attendees participating in a wide variety of activities. Their reunions are for a wide variety of military organizations, and usually each numbered unit mingles mostly with themselves. Our Outlaws reunions are for one unit - -- the Outlaws, and usually have from 80 to 150 attendees, but usually average about 120.

The purpose of our reunions has been and continues to be: to renew and build on the camaraderie of all Outlaws, repeat ALL Outlaws, in ALL ranks - - - no recognition of rank is permitted; we use first or nicknames only - - - in ALL year-groups from 1964 on through assignment in the US, Germany, and Iraq. Permitting attendees to split up and go to different venues detracts from available time for renewing our full Outlaws camaraderie. This camaraderie is pivotal to the VLOA's longevity, because we need the right members to assume leadership positions. The best way to identify those leaders is through comradeship and development of personal knowledge of VLOA members during our reunions. We have found the KISS principle works best for us. That means "one size fits all," which is easier to plan for and control, requires fewer Outlaws volunteers, usually gives us something free for number of rooms, meals, venues, etc. that (Cont. on pg. 4)

we use, and supports our central Reunions' purpose of renewing and building Outlaws' camaraderie. In other words, because we make it easier for the reunion provider services, they give us something in return, such as: "X" number of rooms results in a cheaper room rate and getting the Hospitality Room free, thereby reducing reunion costs; "Y" number of venues or meals results in a lower cost for the venue or meals; use of preferred hotel/motel reduces transportation costs for buses; and use of centralized facilities and services results in more free time for attendees and for Outlaws to mingle.

We have experienced "walk-ins" at a number of our reunions, who want to just "pop in" the hospitality suite sessions, have a few beers and snacks with their close friends, pay nothing, only mingle, and then depart. There are costs related to the hospitality room and refreshments. Some have wanted only to come for the arrival or farewell dinner, spend an evening only with their year-group Outlaws and depart. That limited participation in the reunions precludes Outlaws from getting to know and appreciate other year-group Outlaws they have never met. Every scheduled activity provides an opportunity to mingle and renew/build that camaraderie, from meals together, to bus rides together, to libation together, to passing the torch of leadership of the VLOA to other Outlaws who can keep the VLOA moving into the future.

The Silent Auction, now a mainstay of our reunions has two critical purposes: raises much needed funds for yearly operations, and just as important, causes Outlaws to mingle and get to know each other better.

Some would say that options other than full registration are available. We have found through experience doing 10 previous reunions reflects that our approach is the best for our size organization. However, we know there is probably someone who has a real personal situation that would limit their participation. In such cases, they can contact the VLOA National Director and present their justification for variation from the established process. Essentially, these exceptions are on a case-by-case basis, and will be supported only if the National Director and the Steering Committee can work it out and approve it.

As it is, there is a handful of volunteer Outlaws that will arrive two days early at the

reunion site just to fill Welcome Bags, set up the registration area, set up the Silent Auction, prepare the 50/50 Raffle tickets, get audio equipment at the right places, set up the Hospitality Room, preposition and prepare refreshments, etc., for all the Thursday afternoon arrivals. During the reunions, this handful of volunteers will also be working behind the scenes on monitoring the Silent Auction, selling 50/50 Raffle tickets, preparing for the business meeting, replenishing the refreshments in the Hospitality Room, coordinating and preparing the Sunday nondenominational service, preparing and practicing the Sunday evening Missing Man Ceremony, preparing and practicing the Sunday evening Awards Program, and just as important, collecting for Silent Auction bids at midafternoon on Sunday.

In closing, suggestions, changes, and other proposed solutions are welcomed. We continue hearing them and try to find a way to make each of them happen. What I've described above is the way our experience has shown to work best for our size reunions. As the years go by, the VLOA will become a "last man standing" organization, and will need a simpler way to do things (such as our reunions) the closer we get to that date. Hopefully, our leadership has prepared the VLOA for that eventual date and enough Outlaws volunteers will continue filling the much-needed VLOA Steering Committee positions and work during the reunions and during the intervening years to lead our national organization, produce our quarterly *Outlaws Newsletter*, keep our quality website updated with current software and information, keep our Outlaws roster up to date, keep our financial records up to date, and annually file the IRS e990 tax returns to maintain our 501(c) (19) tax-exempt status. Why don't you consider getting involved somewhere in all the things the VLOA has to do to make it the vibrant, active veterans' organization it has become?

We look forward to seeing you in San Antonio this September and at future Outlaws Roundups.

Why No Vendors at Outlaw Reunions?





Those of you who have attended an Outlaw Reunion will recall that there have never been commercial vendors in our halls. Several times in the past, commercial vendors of one form or another, have requested to set up a booth, provide displays, give a sales presentation to the group or offer some form of inducement to purchase their product.

The Steering Committee was canvassed for their thoughts on the issue and voted to set a policy to deny all such requests. Their reasoning was as follows.

First, it was recognized early on in our reunion planning that allowing vendors would markedly distract from the real reasons we hold a reunion, i.e., to further solidify the comradery we once felt for each other during our combat tour. Our reunion planners work hard to provide a reunion environment where we can rekindle those old friendships. The VLOA is open to all former unit members and no rank is ever used to identify anyone.

Second, we found that some prospective vendors would also want to display our unit logos with a numerical designation. As we know, the original 62d Aviation Company was soon redesignated as Company A, 502d Aviation battalion and still later as the 175th Assault Helicopter Company. Showing any Outlaw patch at our reunion, with a specific unit number, would unfortunately create a cleavage between those who were the Outlaws when it was designated with a different number. We are "Outlaws" and our policy is that there is only one patch, that which is without any unit number designation.


Third, we conduct two fund-raising events at our reunions: Silent Auction and 50/50 Raffle. Permitting vendors to sell their wares at our reunions would clearly decrease the potential moneys that would be spent on our two fund-raising events.

So, we have no commercial vendors. However, you will most certainly be contacted regularly (read: again and again) by the team who will be pushing hard to allow you the opportunity to win at the big **50-50 drawing.** Be prepared for their not-so-subtle pleas, urgings, appeals, entreaties, relentless requests and other nefarious means of pulling money out of your pocket for the VLOA treasury as well as possibly enriching your own wallet if you are a winner!

But, NO vendors!

That's An Order!

As the years have gone by, Agent Orange has become recognized as a major source of cancers in Viet Nam veterans. Agent Orange was usually sprayed from either helicopters or from low-flying USAF C-123 aircraft. On several occasions, over 8+ years, Outlaw aircraft were fitted with sprayers and used to defoliate specific areas not appropriate for USAF aircraft. At that time, we were led to believe that the chemical was not harmful.

There is no way of knowing how many Outlaws may have contracted some form of cancer or other medical issues since their tour in Viet Nam. And sadly, we have no knowledge of how many have been lost because they <u>didn't</u> know that Agent Orange may have been the cause of their illness.

Prostate cancer is one of the predominant forms of cancer in Viet Nam veterans. Let me tell you about my personal experience over the past two years.

For nearly 25 years, I used the same Primary Care Physician who regularly gave me blood tests which identified my PSA number. My PSA was generally in the 2.5 to 4 range, appropriate for my age. However, about six years ago my PCP retired and I changed to another doctor. Although Regrettably, I should have been aware of it but it did not occur to me then that he was **not** regularly checking my PSA. About 2 years ago, when he finally gave me a PSA test, my PSA was found to be **124**! Not good!

Biopsies showed I had prostate cancer which had metastasized to the hip and spine. Since then, I have had multiple tests: biopsies, MRI's, CAT scans, 4 weeks of radiation, injections, more blood tests, etc. Fortunately, my PSA has gradually dropped from that frightening 124 down to about 6.0. The doc's tell me that I'll always have prostate cancer but, with the decrease in the PSA, it can be somewhat controlled. All those "ologists" tell me that I'm not going to die of prostate cancer but something else. (When I ask them "what" and "when", in typical MD fashion, they are quite evasive about answering).

The VA has determined that my cancer is attributable to service in Viet Nam and has given me a 100% VA disability rating. Although the rating comes with a financial compensation from the VA, I would gladly forego that compensation if it were ever found that I was no longer entitled to it because the cancer was gone. (Not going to happen),

Obviously, I was far too casual, for too many years, about remembering the importance of that critical PSA test. But the lesson learned here is that you MUST have regular blood tests, at least once a year, to include PSA readings! Don't let happen to you what I allowed to happen to me.

So, my urgent admonition to you, NO, my <u>direct order</u> to all of you is, get that PSA test, now!

That's an ORDER!





Directors' and Outstanding Outlaw's Award Nominations

Women Helicopter Pilots

A Little History

When the Outlaws served in Viet Nam, none of us would have thought that, in a few years, Army Aviation would include women as contemporaries in the heretofore all-male fraternity of helicopter pilots. However, in 1974 the Army began training female helicopter pilots and, by 1993, had integrated women Aviators into combat unit assignments.

Women now fly every type of Army helicopters and Army fixed-wing aircraft. Although women Army Aviators are no longer viewed as "unique", as perhaps they were in earlier years, today's women Army Aviators are a proud part of the lineage of women pilots (especially helicopter pilots) from the past.

History tells us that on August 1 1911, **Harriet Quimby** was the first woman to receive a license to pilot an airplane in the United States. However, it took the US military 65 more years to recognize and train women as pilots. Even then, it took an additional 17 years to permit women to "invade" the sacrosanct area of piloting <u>combat</u> aircraft. Those of us who flew, serviced and crewed Outlaw helicopters in Viet Nam came several years before women would be part of the unit personnel structure.

Helicopter history records that a German woman pilot, **Hanna Reitsch**, was the **first female helicopter pilot**, and flew a Focke-Achgelis FA-61, the first fully controllable helicopter. Interestingly, in 1938, making daily flights, she flew the FA-61 during an International Auto Exhibition **inside** a large exhibition hall in Berlin. However, Hanna was a close friend of Adolf Hitler which made her a star of Nazi propaganda. After a career of dubious achievements, she died in 1979.

Also, looking way back, Viet Nam helicopter pilot history describes an exceptional French Army woman helicopter pilot who served in Viet Nam many years before the Outlaws arrived. Valerie Andre, holds that distinction. Not only was she a medical doctor (a neurosurgeon!) she also trained as a "medevac" helicopter pioneer—and was the first woman to fly a helicopter in combat. Between 1951 and 1953 Andre flew 129 combat medevac missions in Viet Nam, rescuing 165 wounded French soldiers. Fastforward to the early 1960s. André, now serving with the French Army fighting in Algeria, flew an additional 236 combat missions flying Sikorsky helicopters. (Cont. on pg. 16)

so n h (Cont. from pg.15) It would be extremely unlikely that an Army medical doctor, flying "Dustoff", would happen in today's military services.)

Today, all US military services have women helicopter pilots. Women Army Aviators have more than proved their ability to perform on an equal basis with their male counterparts. Women helicopter pilots have seen duty in Iraq, Afghanistan, Kosovo, and all major conflicts in the army's recent history.

In July 2009, Air Force Major **Mary Jennings Hegar**, on her third tour in Afghanistan, although was severely wounded and shot down while piloting a Med-Evac Black Hawk helicopter in Afghanistan. Nearby Army helicopters rescued her, along with other soldiers, but the rescue helicopter was full and she and a few others had to fly out standing on the skids. She received a DFC with combat V for her actions on that day.

Today's women Army Aviators continue to build a legacy of their own. For example, **Tammy Duckworth**, an Army Black Hawk pilot, was among the first handful of Army pilots to fly combat missions during Operation Iraqi Freedom. She lost both legs when she was shot down over Iraq on November 12, 2004. About 120 hours into her tour, her Black Hawk was struck by an RPG. As a fireball tore through the cockpit, Duckworth tried to help land the chopper but was unable to use her legs and feet on the foot pedals. She was the first American female double amputee from the Iraq War. Duckworth is now a US Senator from Illinois.

An early prominent woman Army Aviator is now-retired **Colonel Sally Murphy**. She joined the Army in 1972 and immediately entered flight training when Army Aviation opened its ranks to women. Murphy was awarded her Army Aviator wings on June 4th 1974 and became the **first female Army helicopter pilot**. (An interesting side-note of her career was that, while stationed in Germany several years later, she commanded the **62d Aviation company**, the original designation of the H-19 and H-34 Outlaws when they arrived in Viet Nam in 1964.) Colonel Murphy had an outstanding career, at all Army levels, with Army Aviation. She retired in 2009 after a distinguished 37-year career in Army Aviation.

Captain Shay Haver is one of the more well-known examples of women's ability to excel. In the footsteps of her Army Apache-pilot father, she also started her Army aviation career as an Apache pilot. In 2015 she became one of the two first women to ever graduate Army Ranger School. (Cont. on pg. 17)

After completing Ranger School, Shay branch-transferred to Infantry, where she commanded an infantry company at Ft. Bragg, NC. Haver was honored to lead the military honor guard that carried the casket of US Supreme Court Justice <u>Ruth Bader Ginsburg</u> when she died and <u>laid in state</u> at the US Capitol.

Another distinguished woman helicopter pilot is now-Lieutenant General Laura Richardson. Laura was a Blackhawk pilot who flew combat missions during the first year of the Iraq war in 2003. Her husband, also an Army Aviator, (and also a Lieutenant General) flew Apaches in seven combat deployments. Laura became the first female, combat arms General officer and together, they hold the distinction of being the first "dual-military" three-star General Officer couple.

To continue her massive success, in 2019 Lt. General Laura Richardson, was selected as commander of United States Army North. She is the first woman to hold this position and is one of only a handful of female officers to achieve that rank. On March 6, 2021, President Biden announced the nomination of (Army Aviator) Laura Richardson to become the next commander of United States Southern Command. Indeed, quite a distinguished career for a woman Army Aviator.

These paragraphs recognize the accomplishments of only a few of the women now in Army Aviation. It should be remembered that literally hundreds of other officer and enlisted women contribute daily to the success of today's Army Aviation force without special recognition or acknowledgement.

Each month more exceptional women graduate flight school and begin their journey of conquering their world as Army Aviators. They tolerate incredible stress and balance work and flying in both their personal lives and in their families. And, they thrive on adversity! Women have long ago shown, and continue to demonstrate, that they are more than capable of performing as competent pilots and impressive leaders. Their achievements and successes will continue as their numbers grow and their legacy continues to shine.

Doug graduated from Midwestern University ('57) and began a career in the United States Army. He served his country for 27 years which included one tour in Korea and two tours in Vietnam. He was awarded many individual and group decorations including the Distinguished Flying Cross, Soldiers Medal, Bronze Star and Purple Heart. Doug retired from the military in 1983.

Doug earned a Master of Business Administration in Aviation from Embry-Riddle in 1983 and began a second career at Martin Marietta (Lockheed Martin). He retired in 2003 after 20 years of service.

Robert "Bob" J. Wegner

Jet-pilot and golfer, Robert J. Wegner, has died at the age of 71. He was born to Helen and Donald Wegner on October 7th, 1949 in Queens, New York, where he matriculated until leaving for active duty at 19. Bob Wegner's aviation career began with The United States Army, as a helicopter pilot during The Vietnam War in South East Asia. During his service, he was shot down several times; not only did he survive but he saved the lives of several other service men in the aftermath.

The Army Commendation Medal and The Distinguished Flying Cross were awarded to him for, "single acts of heroism or extraordinary achievement while participating in aerial flight." He began a nearly fifty year marriage to Terry Monica Kraus at a Long Island celebration hall in 1973. They had two children together, Nicole and Zach. Although the family spent the majority of their lives as residents of Gaylordsville, CT, Bob was a man of the world, travelling to almost every continent during his storied career as a jet pilot for Time Magazine and The Rockefeller Family's *Wayfayer Ketch Company*. He flew Gulfstream jets for decades and later became one of the *NetJets* company's pilots. In his early forties he began his journeyman pursuit of golf: a sport which he mastered up to a 4 handicap.

Many in the New Milford community knew him as a carpenter, a handy-man, chef, and baker, notably through the abundance of loaves of bread and "to die for" chocolate croissants baked for friends during the earliest days of the COVID-19 pandemic. His handiwork lives on in The John Pettibone School's wooden playground and backdoor patios across the tristate area. An avid learner, reader and seeker, Bob often reminded those around him that, "Nobody ever learned anything while they were talking." For almost thirty years he led a life of sobriety, and shepherded many others to do the same in the meeting spaces of Alcoholics Anonymous. Some of the local men in recovery are said to have never missed a meeting helmed by "Bob the Pilot." Ever since his October diagnosis he fought to live against the growing metastasis with the same passion he had done everything. Only in his final months could he ever be observed lying down.

He left his body on Wednesday June 22nd, 2021 after the 10-month battle with esophageal cancer had ended. He is survived by his daughter Nicole, his son Zach, his wife Terry, his mother Helen, and his brother-in-arms Joseph Sheeran. Bob will be honored next to the 18th hole in a celebration of life at *The Club at River Oaks* at 2 Evans Hill Road, Sherman, Ct on July 11th, 2021 from 1-5 pm.




Harold D Quattlebaum
