


I would like to share with you what I see when I look out to the south out of my window, not just on the 4th of July but everyday!

#### NATIONAL MUSEUM OF THE PACIFIC WAR/HISTORIC FREDERICKSBURG Friday, September 23

# Here's where we are; Where are we going?



Our Outlaw heritage began back in 1964 when a collection of young soldiers learned they would be banded together to move from a comfortable place called CONUS, to a not-so-lovely vacation village called Vinh Long. In all wars, soldiers in a combat environment are certain to have a special bonding with each other. However, that 50+ years ago banding together, ultimately resulted in a life-long relationship between those soldiers. And, that banding together was further cemented with the formation of a unique "club" now known as the Vinh Long Outlaws Association (VLOA).

The VLOA "club" is now in its 33d year of continuing to cement the bond between all those nowold soldiers. Unfortunately, the passage of time has also brought us face to face with some certainties none of us even thought about when the VLOA was formed those three+ decades ago.

One certainty is that all those young 20 -year-olds, who deployed to Vinh Long Vietnam with the early Outlaws are now in their mid- to late=70s! A majority of our old soldiers are in their 80s. (BTW – the "old man" is in his 90s). The obit pages in our Newsletter remind us of the increasing number of Outlaws who have left our ranks.

A look at the number of 2022 attendees, planning to attend the Outlaws' Reunion, is a major concern. The attendee numbers, from previous Reunions, are smaller than we had hoped to see. This smaller number directly impacts the status of a significant number of issues regarding the near-term, and long-term, status of the continuance of the organization.

For the past decade, VLOA leadership has again and again appealed to the membership for volunteers to step forward and fill critical leadership roles. For the past 10-15 years, the same members continue to donate their time (and talents!) to ensure that the Association is managed on a professional and legal level. In some cases, because no one would step forward to fill these roles, for years, the same person has had to fill two or more critical positions. The good thing is, the VLOA has been able to function remarkably well with the few who continue to make the Association "happen." But this can't continue.

There are a number of things that obviously indicate a growing lack of interest in keeping the VLOA alive and functioning. Among the more important things are: increasing number of deaths of members; increasing number of members who do not keep their roster information up-to-date; decreasing number of members who desire to attend our biennial reunions; lack of sufficient volunteers to fill the pivotal officer/director positions; significant decrease in number of membership renewals; increasing costs to publish the quarterly *Outlaws Newsletter*; a negative cash flow for the last three years due to Covid19 impacts; and the like.

Our National Director is key in holding the organization together, pulling the strings to ensure the right things take place at the right time and to the standards outlined in our VLOA Policy Files. We have never had to beg someone to hold this position in prior years. Yet, this time, numerous members were asked to fill this position but none accepted. In turn, one of our former National Directors has offered to take the position again in order to keep the organization alive for the time being.

The Deputy National Director's position is critical to filling in when the National Director is unable to function, and even more importantly, following up on "Lost Outlaws" and leading the Directors-At-Large in the search effort. The previous Deputy National Director resigned, and no one has offered to fill this position.

The Secretary is responsible to ensure the Outlaws Roster is accurately maintained because it is the document that drives the communications efforts between the VLOA and its membership.

Additionally, the accurate roster is extremely important because it is the document that provides the justification to the IRS that our membership levels meet IRS requirements. Finally, the Secretary is responsible for capturing the minutes of our Business Meetings during our biennial reunions. Again, no one has offered to assume this position, so the current Secretary continues to perform these duties, and has done so for more than eight years.

The Treasurer is appointed by the National Director, but as with other positions, the current Treasurer has been performing that duty for more nearly 12 years, due mainly to no one offering to fill that position. Additionally, the Treasurer must audit the VLOA Roster to ensure its accuracy, so he is just as involved in the roster upkeep as the Secretary. Currently, the Treasurer is performing one of the Secretary's duties of making and sending Membership Cards to dues paying members, mainly because the Secretary does not have the computer programs to do professional membership cards. The Treasurer has also assumed the duties as Chair, Awards Committee which is responsible for evaluating candidates for the Directors' Award and the Outstanding Outlaws Award. Finally, the Treasurer performs a very key effort during the spring of each year by filing the IRS tax return for the organization. By way of interest, he is closer to 85 years of age than he is to 84.


This discussion can go on further for many other positions; the *Outlaws Newsletter* editor has been doing that job for more than 10 years; the Outlaws Website manager has been in that position for more than six years; and our Historian has been in that position for more than 20 years.

Don't you think these volunteers deserve a "thank you" for keeping this organization alive? I do! Don't you think that you younger folks ought to step up and fill these pivotal positions so the "old folks" filling the positions now will have some time to transition the jobs to you? I do! Because, if the offers are not forthcoming, then there is but one way the VLOA can move. And, that is to make the decision to dissolve the Vinh Long Outlaws Association, and close it out in the manner we finalized in our Constitution and By Laws that we provided to the IRS for approval of our 501 (c)(19) war veterans organization.

Some who were asked to fill a position stated that they would not know how to perform in any of the positions. Thankfully, that problem was solved many years ago when two "volunteers" spent the better part of six months documenting a set of Policy Files that discuss everything that is done by and for the VLOA. All officer and director positions are discussed in detail, as are every action that someone must take. So, there is plenty of written guidance for anyone to step in and take over one of the officer/director positions. These Policy Files were specifically developed to resolve the "transfer of leadership" situation as all of us ultimately pass on. It's time for the younger year-group members to step up and assume that leadership.

In closing, it took herculean efforts on the part of a few original Outlaws to get the VLOA formed, financially sound, and worth the effort to keep the camaraderie spirit alive and grow the organization. We have lived of the eagerness and esprit of the relationships and camaraderie for many years. Now, we have migrated to a handful of volunteers trying their dead-level best to keep the organization alive. We have come full circle. It is up to you, the membership, to determine "where are we going." Is it time to lower the curtain on this wonderful play we have all participated in for more than 50 years? We sincerely hope not!

# 2022 reunion Shirts Order Now!



As was stated in the previous Newsletter's, the Reunion shirt is a three-colored pattern featuring the official Army Aviation branch colors of brilliant Ultramarine Blue and Gold Orange with a narrow white stripe separating the blue and gold colors across the shoulder and sleeve. The Outlaw logo will, of course, be displayed on the front of the shirt, and trimmed in gold to match the gold stripe on the shirt.

This year's shirt is again a Sport-Tek tri-color, micropique material, which we have had in the previous years.

As always, both men's and women's shirts are available. The shirt order form, found in this Newsletter, show pricing and order instructions. Assuming the reunion can, and will, be held, the NTL (No Later Than) date-August 31st, 2022— for ordering, still remains valid. That NLT date applies if the reunion can be held in September as planned. If the Reunion is decided to be pushed back, a later NLT date will be announced.

We have been through other Viet Nam displays and mockups, but this one, by far, was the most intense. As we "Walked" through a "street in Saigon" and "watched" battlefield activity from a bunker, and then walked around the compound, we heard the constant sound of the Huey's and of the mortars. Is it any wonder that our guy's still have nightmares and other forms of PTSD after 50+ year's.
- #2- I learned that we, "Outlaw Wives", are not only proud and respectful of our guy's, but we are also protective. I looked around the Viet Nam Experience and saw other wives doing exactly what I was doing! We all had an arm around our guy's asking," are you okay?", (because most of us WERE NOT!)
- #3- My next lesson came the day the reunion was over. John and I stayed an extra day and took the boat out to Ft. Sumpter. Upon returning I took my second helicopter ride. It was not yet on a Huey, (on my bucket list), but in a 4 place Robinson-R-44 Raven. The difference was that unlike my first ride, the pilot had taken the left door off because the weather was so nice. Of course, I had a lap seatbelt on, but only the door frame to hang onto. As we banked to the left over Charleston Harbor, I felt more than a little uneasy. Of course, we safely landed a few minutes later. As we walked back to our truck, I told John that I had a whole new level of respect for him! When he asked me why, I simply said, "I was only a few hundred feet above Charleston Harbor with a door open; I can't even imagine hanging out of an open door of a Huey with an M-60 machine gun, over the Mekong River, while being fired upon"!!


Once again, "Kudos" to ALL our OUTLAW and MAVERICK pilot's, co-pilot's, crew-chiefs, gunners and all the support personal!!

## The Birth of the 62d Aviation Company – Outlaws!







In early 1964 I was completing a three-year tour in Hawaii when new orders sent me to that newly activated 11<sup>th</sup> Air Assault Division at Fort Benning, GA. As we all know, almost everything about the Division was either different or new. The structure. The training. Aircraft of various models and types we were not yet familiar with. And on and on.

After reporting in, I was assigned as the S-1 of the 226<sup>th</sup> Mohawk battalion. Just as with many things about the Army in those days, the Mohawk was also new to Army Aviation. I was put on the list to go to Rucker for transition into the OV-1 Mohawk. (PS -I was never eager about flying the Mohawk.)

However, after a couple months getting comfortable with the S-1 job, (and awaiting transition into the OV-1) another job change! I was now being reassigned to 11th Aviation Group headquarters where I was to be the G-1 of the Group, a job I welcomed after several previous stints in the "people" business.

However, after several more months in that job, fortune stepped in again and I was offered command of the newly activated Company C in the 229<sup>th</sup> Aviation Battalion. Couldn't ask for a better assignment! Again, everything was new, not the least of which were all the personnel in my Company.

My new Battalion CO was Lt. Colonel Del Townsend. On a Saturday evening several weeks after taking command of C/229, Col Townson called me at home to ask what I was planning for next Sunday. My family and I had planned to spend Sunday picnicking together at a nearby Lake. So, it struck me as curious that my Battalion Commander would ask if he could join us.

Interestingly, after lunch at the lake, Colonel Townsend asked me to go for a walk with him. His purpose was to alert me that I would be getting a call the next morning to report to the 11<sup>th</sup> AAD Commanding General's office! What a distressful night that <u>might</u> have been. However, Colonel Townsend discretely informed me that the General's purpose was to tell me that I would be immediately activating and deploying a UH-1 company to Viet Nam.

When I reported to the General's office the next morning, I met another Army Major, who had no idea of why we were there. (Thank you, Col Townsend for alerting me!)


Imagine our surprise when the General met us at the door, invited us in, offered us a seat and a cup of coffee. He then went on to outline why we were there. (And, why two of us?)

The General told us that two UH-1 Aviation companies were to be activated from within assets in the 11<sup>th</sup> AAD and that he had selected the two of us to command the two units. One unit was slated to be in Viet Nam within just over a month, the other 30 days later. The unit designations were the 62d Aviation company, the other the 3d Aviation company. We had our choice of which unit number we would prefer but did not say anything about which unit would be going first.

So, the General suggested flipping a coin, the winner would have his choice of which unit designation he would prefer. I won the toss and, for no reason, selected the 62d Aviation Company! And, the rest is our Outlaw history. To say the next month+ was hectic could not come close to the reality.

As we all know, the (62d, A/502d and 175<sup>th)</sup> Outlaws amassed an outstanding combat record during their 8-year history in Viet Nam.


I have always been overwhelmingly proud to have been selected as the first "Outlaw", even before the "Outlaw" name was selected. Tom Anderson.




