

## The Original Outlaw Skull



In 1947 Captain Al Kinder, US Army Air Corps (later the US Air Force) was assigned to Davis Monthan Air Base in Tucson, AZ. Al was a seasoned combat veteran who had served in both the Pacific and European Theaters as a bombardier/navigator flying in both B-26 Marauders and B-17 Flying Fortresses. He had been awarded the DFC, Air Medal with 7 Oak Leaf clusters and his unit the Presidential Unit Citation. Little would he realize, as a University of Texas graduate in 1942, how future world events would change his life and his new assignment would eventually link him to the Vinh Long Outlaws.

In 1948 Al met Mary Ann Adams and they were married. Al separated from the service and went to work for Mary Ann's aunt in the warehouse and transfer business.

Along came 1951 and, through a connection with Davis Monthan Air Force Base, Al was asked to help an Air Force widow find a house in Tucson. The lady was Gertrude "Babs" Bergquist, widow of Colonel Ehrling Bergquist who had been killed in a tragic airplane crash in February 1948 at Offutt AFB, Nebraska. By then, Babs had two children, Barbara (14) and **Bob** (10). They settled in Tucson in a house not far from Al Kinder and the two families established a life-long friendship.

As the **Berquist** children grew, Al became somewhat of a surrogate father to them. He watched them grow up and attend college. Bob enlisted in the Army, completed OCS and Army Aviation rotary wing training at Fort Rucker. As a newly minted helicopter pilot, he was assigned to the 11<sup>th</sup> Air Assault Division at Fort Benning and, when the 62d Aviation Company was activated, assigned to that unit which was bound for Viet Nam.

1<sup>st</sup> Lt. **Bob Bergquist** accompanied the Advanced party to Vinh Long. Very soon after their arrival, the Advanced group selected the call sign Outlaw for the unit and the very appropriate name of Mavericks for the gun platoon. Shortly thereafter, Bob set about designing the Outlaw patch and the Maverick logo, both of which were quickly adopted as official emblems of the unit. Not satisfied with just the patch design, and with the skull as the predominate feature of the patch, Bob started thinking about how to get a real southwestern steer skull for the unit in Vinh Long.

In one of many frequent tapes and letters to his mother about his experiences in Viet Nam, he asked her to see if she could obtain a real steer skull and have it sent to him. His mother, "Babs", frequently included the Kinders in reading and playing Bob's tapes because of their friendship and interest in the family. Perhaps Bob, in his always optimistic thinking, thought his mother could simply comb the Arizona desert and easily find the desired skull. It soon became apparent that the task of finding a skull somewhere out in the desert was not to be. So, Bob's mother "Babs" turned to the Kinders for help.


Al, being a practical man, immediately went to a local slaughter house and purchased a newly severed head from a steer. He then took on the project of reducing the head to a skull. The task was, by no means, simple. Al fashioned a cauldron to contain the head, built a large fire in his back yard, and began boiling the head in order to remove the flesh. Naturally, the odor coming from Al's back yard did not endear him to some of his closest neighbors. After several days of boiling, and the head had cooled, Al had to remove the cooked flesh. He carefully scraped the head and sun-dried the skull for several weeks before it was fit to send to Bob in Vinh Long.

When the skull was ready for shipment, the next hurdle was sending it to Vinh Long. Al again turned to some of his remaining connections at Davis Monthan AFB for help. Once the story of the skull, and the helicopter unit in Viet Nam became known, the Air Force made transportation arrangements for the skull to be sent to Travis AFB, then on to Than Son Nhut AFB, and finally to Vinh Long by C-123 aircraft. Soon after the skull arrived, a large painted sign of the Outlaw patch was fashioned and the skull permanently affixed, it was placed immediately outside the 62d Aviation Company's orderly room.


A mystery remains to this day as to the whereabouts of the Outlaw's original skull, which had such an interesting tale and journey to Vinh Long. It should be noted here that the original patch design, featuring a southwestern steer skull, designed by Bob Bergquist, was "bastardized" and a water buffalo skull appeared on later renditions of the patch. Who did this??? And, where is the original Outlaws steer skull today?

Editors Note: Al Iller, the second Outlaw 6, wrote the original story of the Outlaw skull which appeared in the April-June 2006 edition of the Outlaw Newsletter. Al obtained information for that story which was originally provided by Mrs. Al Kinder of Tucson, AZ and Mrs. Rebecca **Bergquist** Quinn of Huntsville AL, through several telephone interviews.

## The Indispensable— Huey Crew Chief...



In Viet Nam, the typical helicopter pilot would complete a day's mission over Viet Nam by putting his aircraft in its overnight location, hit the battery switch, scrawl his name in the flight log and seek a remedy for the hazards of a day's mission.

His confidence had to have come from his knowledge that the next day, early in the morning, he will preflight the same aircraft in the half-light of another morning and fly it over a country not known for its "hospitality" to pilots who "drop in" unexpectedly. His confidence was more than justified by the continuing efforts, skill and competence of a 67N20, otherwise known as the "Crew Chief". Crew Chiefs were responsible for maintaining every aspect of the Huey.

Pilots often thought that an aircraft was THEIR aircraft. In reality, they were only renting the machine for the day. When the day was over, they would return the aircraft to the REAL owner of the machine, the Crew Chief.

On arrival in the Outlaws, a new crew chief might normally have been assigned to the Service Platoon to work in the hangar to familiarize himself with the procedures and techniques used in Viet Nam. After proving himself in the hangar, he was assigned his own aircraft as the Crew Chief.


In the Outlaw unit, the duties of a crew chief were <u>enormously</u> important! The complexity of the aircraft and equipment he was responsible for, and the proficiency expected of him, placed him, among an elite group on whose shoulders rested the life and safety of every crewmember who was in the bird when pitch was pulled.

His day normally began early, usually about two hours before dawn. To ensure that the aircraft was mechanically ready, he might start by checking the head and stabilizer bar, then check the oil gauges, the hydraulic system, the electrical systems and the fuel intake. He supervised all loading of the aircraft to insure a safe center of gravity.

In flight, he monitored the pilot/crew intercom to know the mission, current situation and potential dangers. He would watch below for the enemy, and along with the door gunner, lay down suppressive fire when needed. He was constantly on alert for abnormal noises from the engine or transmission. He was responsible for ensuring clearance for the tail rotor in tight landing zones. Whenever the aircraft would be shut down, he didn't have the luxury or time to grab a "C" and relax. He would inspect every potential problem area.

When the mission was completed and the aircraft shut down at the end of the day, his work just began. He would start by making his daily inspection, clean and grease the head, clean the air filters by running water through them, check the engine for loose or worn fuel and oil lines, grease the tail rotor, check the engine for loose or worn parts, check the oil gauges, the hydraulic and electrical systems and the stabilizing bar. His job was to make sure all components were functional for the next day when the pilot would return to again rent the Crew Chief's aircraft for the day.

(Yes, that's probably more information than you ever cared to know, but at least now you are much more historically educated!)

The reunion shirts are a Sport-Tek polo tri-color micropique material. We've had this style shirt in the past and it has been very popular. This year a unique, and very attractive shirt feature will be the Outlaw logo trimmed in gold, to match the gold stripe on the shirt.

#### Who was Jeannette Smith?

As most of you know, Jack Sanford was the first Maverick Lead. He was an outstanding soldier. He was 33 years old when he was KIA on 16 June, 1965 and already had 18 years military service. He enlisted in the USMC at 15, was found out when he was 16 and serving in China. He was sent back to the US, discharged but enlisted in the Army at 17. As a platoon sergeant in Korea he received his first purple heart. Jack met and married Jeannette when he finished OCS and later went to flight school. He earned a black belt in TaeKwonDo. He finished his college degree through the Army's Boot Strap program. Three weeks before he was killed, he took a round into the side of his neck, was hospitalized for four days before insisting that he was OK and demanded that he be returned to Maverick duty.

His wife, Jeannette, was just as driven, ambitious, outgoing and outstanding as Jack. When Jack deployed to Viet Nam with the Outlaws, Jeannette wanted to be near him. As a dependent, she couldn't come to Viet Nam, so she did the next best thing. She obtained employment with the huge Viet Nam civilian construction company RMK/BRJ and asked to be sent to Viet Nam as a civilian. It was early in 1964 and rules could be slightly bent to allow Jeannette to occasionally come to Vinh Long to visit Jack and the Outlaws. She was working in Saigon when Jack was killed. A close friend, Captain Bryce Kramer flew to Saigon to break the news to Jeannette, and then accompanied Jacks body back to Arlington Cemetery where he is interred beside thousands of other American heroes. Jack was posthumously promoted to Major. Although Jeannette remarried another Army aviator, who also predeceased her, she never lost touch with the Outlaws. Over the years she attended many of the reunions and became friends with numerous Outlaws who never knew Jack but were delighted by her charm. She also made sure that she regularly submitted items for the Silent Auction. She insisted that she receive the Outlaw Newsletter.

Sadly, Jeannette's obituary made no mention of her first husband, Jack. A number of her friends wanted todays Outlaws to know who she was, that Jeannette Sanford Smith was very much a member of the Outlaws and will be fondly remembered by her many Outlaw friends.

God rest her soul.


#### Daniel M. Bustamante
