How has the VLOA Continued to Function, and Grow, for over 2 Decades?

Recently, we saw humorous video clip of the now-retired NFL quarterback Peyton Manning who was supposedly becoming a resident in a **Florida Seniors** home. The Home Director told Peyton "Remember, everyone in here is in their 4th Quarter - with no time-outs left". Guys, that's where WE are, whether we will admit to it or not.

However, on a more positive note, the VLOA is **NOT YET** in that 4th quarter! Everyone seems to agree that our great Association can remain viable, hold reunions, maintain a positive cash position, and continue with our newsletter and website, for at least another 10 or more years! But..... that viability will <u>absolutely</u> require members to continue to step up and make themselves available for positions now being held by some of those who are already "well into their 4th quarter".

The last Outlaw Newsletter featured an article which pointed out the obvious, that **volunteers** are what makes the Association run.

Since its inception, literally <u>dozens</u> of Outlaw "**volunteers**" have participated in "making things happen" in the Association. These tasks range from minor items to major components of our VLOA structure. A "look-back" at some of the tasks that have performed over the past two decades, and by how many different individuals, identified <u>at least 104 individual members</u> who have contributed their time and effort to the dozens of functions needed to keep the Association running so smoothly. Without naming individuals, here's a very unscientific summary of a number of the functions and tasks which those 104+ Outlaws have performed.

To begin with, we have been fortunate to have had 10 extremely capable <u>National Directors</u>. Additionally, 4 members have served as the <u>VLOA Secretary</u>. The <u>VLOA Treasurer</u>, an appointed position, has been fortunate to have had 5 members manage this crucial, and time-consuming task. Additionally, more than 25 members have served as **Steering Committee Members-at-Large**.

11 different <u>Reunion Coordinators</u> donated hundreds and hundreds of hours, over at least a year's time, to plan, coordinate and manage the hundreds of activities required for successful reunions. At the reunions, several members have served as the <u>Master of Ceremonies</u>. Additionally, at each reunion Farewell dinner, 3 members have traditionally narrated the stirring <u>Missing Comrades Ceremony</u>.

Our acclaimed <u>VLOA website</u> has been managed by 5 different, and extremely talented, members. The <u>VLOA Newsletter</u>, one of the most visible, but time-consuming, components of our Association, has had 6 members take on this VERY demanding position.

A number of years ago, 1 of our members volunteered to be the <u>VLOA Historian</u>. The Historian has taken on the herculean task of collecting and historically documenting literally <u>thousands</u> of military records, photos, videos etc. relating to the founding, growth and history of our Association. These files will ultimately be forwarded to the Texas Tech Viet Nam Center and Archives.

The largest money source for the VLOA treasury, the Reunion <u>Silent Auction</u>, has been managed by 5 different members. The second most lucrative financial source, the Reunion 50/50 raffle,

it has been coordinated by 3 different members. The VLOA could not continue to exist **without** these two vital activities.

No organization could function if it does not know WHO its members are. Our current VLOA roster of more than 600 names began with 6 or 7 members researching dozens of sources to form the initial roster of a few dozen names. Since then, the vital <u>VLOA Roster</u> has been diligently maintained by 6 members. Each dues-paying member receives an official <u>Membership Card</u>, prepared and mailed by one of the 4 members who have taken on this activity over the years.

2 members designed our 5 Outlaw logos. Later, 1 member spent months obtaining government approval for **copyrighting our VLOA logos** which protects the artists proprietary rights, protects VLOA's right to these logos and prevents the possibility of others using our logos for commercial gain.

4 members contributed to obtaining the IRS <u>501(c)(19)</u> tax-exempt war veterans organization status for the VLOA. Moreover, for over 20 years, 1 of these members has continued to ensure that VLOA's <u>Federal Income tax report</u> is submitted on a timely basis.

Most members may not be aware that, when we know of a member loss, the VLOA sends <u>Condolence</u> <u>Cards</u> to the families of our deceased members. 6 members have taken responsibility for performing this rewarding task over the years.

A VLOA Memorial Committee, consisting of 3 members plus the VLOA Steering Committee, several years ago, designed, had constructed, and obtained approval to emplace a large <u>Outlaws Memorial Stone</u> in Veteran's Park at Fort Rucker. Moreover, the same group was responsible for obtaining approval to also mount a beautiful 12X18 <u>Outlaw Memorial plaque</u> just inside the main entrance to the Fort Rucker Army Aviation museum.

A massive 55+ page <u>VLOA Policy File</u>, which outlines procedures, policies and history for literally every facet of managing the VLOA structure, was developed over two years primarily by 2 VLOA members. 3 members collectively established a membership-approved <u>VLOA Awards Program</u> for recognizing deserving members at Reunions. Additionally, 2 members have taken on the task of <u>Reunion Photographer</u> at several reunions.

As you can see, the VLOA organization has continued to thrive, and grow, based on the willingness of its members to step forward to assume a wide variety of roles necessary to perpetuate our fabulous veteran's organization.

The purpose of outlining all this VLOA history is to, hopefully, encourage members to offer their service and time to the operation of the VLOA in any appropriate way. At the general membership meeting at the (hoped-for) 2021 reunion in San Antonio, there will be a floor discussion of the need for members to do just that.





VINH LONG OUTLAWS ASSOCIATION (VLOA) "COPYRIGHTS REVISITED"

(Extracted from *Outlaws Newsletter*, *Jan-Mar 2007*)



Recently, issues about the use of patches and logos representative of the Outlaws and related suband attached-units have come up, and bodes well for republishing an article that addressed these issues some 14 years ago. Essentially, any item provided for use by the Vinh Long Outlaws Association (VLOA), such as pictures/photos, articles, logos, and similar items become the property of the VLOA and cannot be used by other individuals or organizations without the written consent of the VLOA. Before approving such use by others, the VLOA will seek release by the provider of the items. However, with regard to the logos for the Outlaws, Mavericks, Roadrunners, and 28th Signal Detachment, these logos have been copyrighted to protect the VLOA and the individuals who designed, finalized, and provided them to the original Outlaws in Vietnam. The following article explains further the VLOA policy for use of these copyrighted logos.

Comments by Frank Estes

"The lead article (page 1) of the VLOA Newsletter, January - March First Issue 2007 provided background, decision process and final approval by the U.S. Copyright Office for the copyrights to the original artwork of the Outlaws patch, 150th Cargo Helicopter Field Maintenance patch, 28th Signal Detachment patch, and the Maverick and Roadrunner logos. In that article, it was stated that the purpose and intent of the copyright effort was to preserve and protect historically the artwork and designs of the patches and logos as originally created by members assigned and/or attached to the 62nd Aviation Company (later re-designated Company A, $502^{\rm nd}$ Aviation Battalion, and then 175th Assault Helicopter Company), 150th Cargo Helicopter Field Maintenance Detachment and 28th Signal Detachment when first deployed from CONUS to Vietnam in late 1964.

"These five patches/logos were approved by the U.S. Copyright Office in August 2006 as of September 2005 submission. Since the approval of the VLOA copyrights, there have been comments and concerns from various sources as to the intent of VLOA's copyright action. As set forth in the above earlier referenced article, and reiterated above, the purpose was to historically preserve and protect the original artwork and designs through the copyright action. As quoted in that same article, "The wearing, display, reproduction, use, etc. by any former members of the 62nd Aviation Company; Company A, 502nd Aviation Battalion of the 1964-1965 era, the follow-on 175th Assault Helicopter Company and all their attached units/detachments, throughout their service in Republic of Vietnam, of these original designs and derivatives thereof would not be infringed upon nor inhibited in any way by reason of VLOA holding the copyrights to the original designs." However, the VLOA would discourage the use of designs for commercial purposes and profit, except by organized groups of former members of the referenced units and detachments for the benefit of their group or membership and for other philanthropic purposes. 


The Back Pew

Linda and I hope that all of you are social distancing, getting vaccinated, and staying healthy. As an old expression states – "Hope Springs Eternal." And that expression is the basis for this issue of:

"The Chaplain's Corner."

We moved to my hometown of Paducah, TX last November in order to get away from the problems facing the Dallas/Fort Worth area in view of the Covid epidemic. Paducah is a small, rural, farming and ranching community of a little over 1100 population, positioned at the eastern edge of the Texas Panhandle, midway between Wichita Falls and Lubbock.

When I was born here in 1941 the population was around 3600 and it was a vibrant town, with lots of happenings, three grocery stores, at least six car dealerships, lots of churches, good schools, several doctors, two dentists, and a JC Penney store. In short it was a great place to grow up. My older brother Bob, and I hunted birds and rabbits with our shotguns and .22 caliber rifles without adult supervision, starting at age seven for me and nine for him. Both of us became expert marksmen and when I entered the Army, I qualified expert with every weapon that I trained with while in basic training.

As the expression says, we all get older and things change. Life, Covid, aging, children, Viet Nam, etc, etc. bring each of us to where we are today. My hometown has changed and I'm sure yours has changed as well. For good or bad, change is a constant in our lives.

However, we can have things as they are and wish they were better, or we can count our blessings and MAKE things better in any way we can. Linda and I noticed that Paducah has more than its share of indigent citizens, old and not so old. We discussed this situation and decided that since we have been blessed with success in our lives, we could make a difference in other's lives. We approached the local grocery store owner and arranged for both Thanksgiving and Christmas that he and his staff provide complete grocery supplies, complete with turkeys, for twenty families so that these families could have a nice holiday meal at no expense to the family. Afterwards, when I paid the bill, I asked the manager how this action was received. He and his staff stated that it was one of the better things they had participated in all year.

We wished to remain anonymous for this effort, but I'm sharing this information with each of you as an example of how any of us can help. The needs of our fellow citizens are not restricted to the annual holiday season. Especially now, during this terrible pandemic, I urge each of you to look about and find a way to make a difference in someone's life.

May God bless you and keep you safe.

Directors' and Outstanding Outlaw's Award Nominations

The VLOA has an established awards program to recognize those individuals who have contributed significantly to the VLOA organization. Each of these awards has certain criteria which must be met to receive the award.


