National Director's Corner

Greetings fellow Outlaws:

As we can tell from our national weather reports, summer is here. Temperatures in the Dallas/Fort Worth area have surpassed the one hundred degree mark. I am sure there are other areas that have hit temperatures above the one hundred ten degree mark.

In January's column, I mentioned that I was transferred to the 121st Aviation Company, Air mobile light, shortly after arriving in Vinh Long. I returned from Viet-Nam September, 1965 and was stationed at Fort Wolters, Texas. I instructed there until June, 1967 when I separated from active duty. I went to work for the contractor, Southern Airways of Texas, and did the same job except I wore different patches on my flight suit. When Fort Wolters started to shut down, I was laid off. Then I went to work for Air America.



I flew Bell 204B helicopters in Viet-Nam from May, 71 to Aug 72. I transferred to Udorn Royal Thai Air Force Base and transitioned to the CH-34D helicopter. Most of the flying occurred in Laos. There I met Father Lucian Joseph Bouschard, Roman Catholic Priest. He would hitch hike flights with us to take him to villages that were a great distance away. The U.S. Ambassador to Laos knew of him and authorized us to help him whenever we could.

Fast forward to 6 June 2009. At an Air America Reunion, in Dallas, Texas, Fr. Bouschard was the guest speaker. He completed theological seminary in 1956. His first request for assignments was for Chad, Africa. However, the Church sent him to Laos. He said "when I arrived in Laos, I thought I went to heaven". He spoke about his ministry in Laos.

He shared some of his experiences during his stay in Laos. He arrived 17 Nov 1956. His assignments were to minister his faith to the Laotian people and to care for the lepers. On one occasion he visited a Laotian military outpost. However, there was a Pathet Lao (enemy) outpost a mere two hundred yards away. He told the soldiers that he could not celebrate mass bent over to keep his head below the walls. So he got the soldiers to dig a hole about one and a half feet deep, so he could stand erect while celebrating mass.

On another occasion, while walking to a village, a Pathet Lao soldier appeared from the brush with a rifle aimed at him. Another Pathet Lao soldier jumped out and stopped him from shooting Fr. Bouschard saying that he was a priest and "he takes of our lepers". Fr Bouschard said that he gave a prayer of thanks that evening.

By 1975 Laos fell under the communist rule and Farther Bouschard was ordered out by his bishop. He served approximately eighteen years in Laos. After a few months in Thailand, his bishop assigned him to Borneo, where he served for thirty five years. He retired in Florida after this assignment.

Please start making plans to attend our 2014 Roundup in Washington, D.C. now. It is looking to be an outstanding reunion, thanks to Tom Anderson's hard work.

Reunion Planning For Outlaw Golden Anniversary On Schedule



Planning for the 2014 Golden Anniversary Outlaw Reunion is now well underway. This article is an update on some of the items that are involved to date.

As I reported in the last VLOA Newsletter, we undertook an initiative to solicit corporate sponsorship donations from a number of corporations with direct involvement with Army Aviation. Several of our VLOA members attended the Army Aviation Association convention in Fort Worth, TX, and were able to obtain leads from a number of personal contacts on the trade show floor. In addition, using several sources of defense-related aviation corporations a list of over 60 potential corporate sponsors was developed. Contact names of individuals within each corporation were identified. Personalized letters, on VLOA letterhead stationery were addressed to specific individuals within these corporations. The letter itself was reviewed by several VLOA Directors and their suggestions were incorporated into the final version. Envelopes, featuring the Outlaw 50th Anniversary logo alongside the return address were printed. Letters were folded, inserted into envelopes and stamped with a US FLAG stamp. On June 5, 2013, 60 letters were placed into the US mail.

Regrettably, the response to this effort has been disappointing. By the middle of July 2013, two firms have responded with turn-downs. I'd like to think that the other 58 are still mulling over our request for their corporate sponsorship and will, in time, forward a sponsorship donation to the VLOA. However, with the passage of time. I'm being forced to the conclusion that, as the saying goes... "It was a long run for such a short jump". So far we have not had a positive response from any of the firms.

My initial hope was that 6, 8 or possibly even 10 firms might respond with the suggested \$500 contribution to the tax-exempt Vinh Long Outlaws Association. That number would make a significant difference in covering some of the likely expenses that are forecast for the reunion. We would still welcome hearing from any corporation that any of our readers/members think might be interested in making a tax-deductible contribution to the VLOA. If you know of such a company in your area, let me know and I'll send them a letter detailing what our group is, why we are soliciting corporate support and asking them for their help.

The largest single reunion expense is the coach transportation (buses) to take our attendees to the various venues planned in our schedule. In the Washington area, costs for coaches can be as much as \$850 per day, per coach. We will need two coaches for two days. \$3400, plus driver gratuity.

However, our Event Planning company, SLM Events, has a good record of successfully negotiating difficult contractual issues and we hope SLM will be able to bring in a coach contract that will conform to the constraints of our budget.

Within the next 90 days we will have a better "big-picture" of the total costs associated with the reunion which can then be used to develop the cost-per-person for attendees. For this reunion, we plan to combine both the hotel reservation cost and all other reunion-related costs so there will be no need to make hotel reservations separate from the reunion registration. In previous reunions, the practice of forwarding separate reservations has resulted in confusion, errors and misunderstandings.

The 2014 Outlaw Reunion Registration Form will be included both in the next VLOA Newsletter as well as on the VLOA website. If you haven't looked at the website recently, browse through it at www.vinhlongoutlaws.com. There are a LOT of good memories there!

Our planning schedule still includes visiting the three significant venues mentioned in the last VLOA Newsletters: A wreath-laying at the Viet Nam Veteran's Memorial, a visit and tour of Arlington National Cemetery and a guided tour of the immense Smithsonian Air & Space museum at Dulles International Airport. The details involved with visiting each of those venues are still being worked out but will be in place in the near future.

Because there are so many significant sites to visit in the Washington DC area, it would not be possible to stretch our schedule to include all possible, or suggested, sites. However, most of our Sunday is being kept open to allow everyone to schedule individual visits to locations they would like to see while in the National Capitol Area. While SLM cannot attempt to make individual reservations to all such areas, if you have a location you'd like to visit, and don't know how to start the process, put a note with your Registration form and we will attempt to provide you a website, phone number or other contact so you can have a head-start in making your own arrangements.

National Director-DNIF — "Duty Not Involving Flying"

Elsewhere in this Newsletter is the regular article from our VLOA National Director, Angelo Spelios. As part of the planning for the 2014 Reunion, I have been in regular contact with Angelo and he has been an active participant in several significant issues relating to the Reunion. Those of you who know Angelo, know that any discussion with him is always friendly and fruitful.

However, in the past several weeks, Angelo has made me aware of a serious medical issue of which his fellow Outlaws should be aware. Angelo felt he didn't want to be the one to write about his situation in his Director's article, but gave his consent for me to convey his issues to you.

A number of months ago, Angelo discovered a growth developing in his right leg, between his thigh and knee. A medical examination disclosed that it was a tumor sarcoma. He began a schedule of chemo-therapy treatments in early June of this year.


The treatment process was to be chemo, then radiation, and finally surgery to remove the tumor.

Recently, however, he felt that the tumor was growing. He had an additional examination which confirmed his suspicions. So, in July the chemo treatments were suspended and a series of radiation treatments were begun. He is receiving his radiation at the world-class MD Anderson Cancer Center in Houston. Once a day, five days a week for a five-week period. At the end of the radiation treatments he will be scheduled for surgical removal of the growth.

Angelo is extremely upbeat and optimistic about his treatment schedule, not only because the MD Anderson Cancer Center is regularly ranked as one of the top two hospitals in the nation for cancer care but also because that's just naturally the way Angelo is! He's looking forward to opening up the 2014 Outlaw Reunion in the Washington DC area. Please keep Angelo in your thoughts

<u>Did You Receive a Purple Heart</u> During Your Viet Nam Service?



Outlaw Jack Bellochio, and wife Dottie, live near a very unique historical center in New York which honors, and recognizes, all military personnel who have ever been awarded the Purple Heart medal. They have made us aware of an organization that should be of interest to all Outlaws who received the Purple Heart during their military service.

The National Purple Heart Hall of Honor was established to collect and preserve the names, stories, of Purple Heart recipients from all branches of service and across all generations and armed conflict, to ensure that all Purple Heart recipients are represented.

A large number of Outlaw members, as well as those who served in attached units during the Viet Nam conflict, were honored for wounds they received by being awarded the Purple Heart medal. If you received the Purple Heart, the Purple Heart Hall of Honor would like to hear from you and ask you to register in their data base. Moreover, the organization would like to have you write the story of how you received your wounds and provide them with a photo of you in uniform if possible.

As you may know, the original award goes all the way back to General George Washington who wanted to recognize individual merit among the enlisted soldiers of his Continental Army. He established the award as a cloth badge to be worn on the uniform.



After the Revolution ended, the award was all but forgotten until WWI, when General Pershing resurrected a form of the award. However, it was not until WWII that the award criteria was changed from meritorious service to one which recognized the sacrifice of all service members who had been wounded, killed or died after being wounded.




